# INTRODUCTION

The Conference aims to rethink and re-imagining disability in the context of the current legislation and policy framework to understand diverse needs of persons with disability. This conference will enable professionals from multiple disciplines to gain knowledge, attitude, intervention strategies. It will enable them to reflect and empower persons with disability and conceptualize ways to design intervention strategies with a rights-based approach. The conference will also highlight the accessibility issues of students with disability in higher education in India. The conference aims to collate the existing knowledge and practices in disability studies and rehabilitation sector. Critically rethink and analyse the gaps and suggest recommendations to the ministry and policy makers of the country in the disability sector. The idea is to converge all the aspects of disability, accessibility, education and wellbeing with a larger goal of inclusion of all. This is an effort to understand the needs of persons with disability to facilitate inclusive development in the country.

The RPWD Act 2016 has raised the expectation of the PWD across India to get quality benefits, provisions and need-based interventions under the 21 types of disability. In current scenario of disability sector, professionals and practitioners are working in a highly specialized manner and they may be lack of awareness about knowledge and diverse practices of other categories of disability, Hence there is urgent need to discuss, dialogue and deliberate regarding each category of disability, rehabilitation and its inclusion process with its multidisciplinary boundaries. This will enlarge the work of the multidisciplinary team to work together in a collaborative manner for understanding future needs of Persons with Disability.

### OBJECTIVES

- To understand the problems, perspective, current scenario of persons with disability and re-imagine the future of disability context in light of the legislation and policy framework to meet their diverse needs.
- To empower and encourage professionals of various disciplines to work in disability sector in multidimensional ways to design needs based intervention with rights-based approach. This conference will focus on the scope of convergence of various dimensions of disability with health, education, awareness, accessibility, technology, inclusive development, and wellbeing with a goal of 'Inclusion for all'.
