1.0 INTRODUCTION

The students registered as PhD Scholars in this University, in accordance with the provisions of governing Direction/ Ordinance shall be required to successfully complete their Course Work, as has been made mandatory by the University Grant Commission published in the Gazette of India, dated 9th Aug. 2019. The Course Work shall be called as 'PhD Course Work' (PCW).

As per governing provisions, no candidate shall be allowed to submit his/ her thesis without PCW Completion Certificate and Consolidated Memo of Marks (CMM) by this University.

2.0 DURATION

A Ph.D. Course work, which will be consider as external component, should be of Min. 90 hours (60 Hours Theory + 30 Hours Practical) either Online or Offline or in Hybrid mode. A detail scheme (Refer Point no. 6) and syllabus is given in Annexure 1. A research scholars must complete the course in the 1st year after registration.

3.0 EXEMPTION FROM COURSE WORK

- The Candidates who have completed their PhD either from this University or any other University recognized by the UGC from time to time shall be exempted from passing PCW examination to the extent of Papers I and II only.
- 2. The Course shall be mandatory for all the students pursuing PhD/ME(By Research) from this University, except exempted under above paragraph. And will be approved by course Equivalence Committee for this purpose. A committee compromise of following members
 - 1. Dean of concern faculty
 - 2. Chairman of BOS of concern subject of faculty
 - 3. One person who is excellence in research nominated by Pro-VC.
- 3. The Candidate seeking exemption shall submit application in prescribed format along with the relevant documents to the A.R. (PhD Cell). All the documents MUST be self-attested by the Candidate himself/ herself.
- 4. The Consolidated memo of Marks will show equivalent marks, granted by the Course Coordination Committee CCC, in the Paper(s) in which the exemptions are granted by the University, with award of respective credits. These marks in Paper I, II and III shall be

generated as per equivalence scheme approved by the University and the marks secured by the candidate in Paper IV and V shall be basis for that. However, it is to be noted that as the Paper IV and Paper V by CHLR (Center for Higher Learning and Research)/ IHLRSS(Institutions of Higher Learning, Research and Specialized Studies) are specific research topic related Papers; all the candidates have to clear these papers.

4.0 CONDUCT OF PhD COURSE WORK

- A PCW (Ph.D. Course Work) shall be conducted by the university. However, if necessary the Vice-Chancellor may allocate the work to specific CHLR/IHLRSS center affiliated to Gondwana University, Gadchiroli.
- A research scholars can complete the Ph.D. course work from the University or following agencies,

UGC-HRDC, NPTEL, SWAYAM, IIT Spoken Tutorial, Teaching Learning Centre (TLC), Ministry of Education sponsored Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching (PMMMNMTT)

- 3. A Teacher from the University Department/ Conducted College/ Affiliated College havin CHLR/IHLRSS should be appointed by the course organizing committee (Vice-Chancellor / Principal) by issuing a Notification. The Vice -Chancellor /Principal shall appoint two other Teachers as the Members in the Course Coordination Committee (CCC), in consultation with the Course Coordinator. The CCC shall chalk out Ph.D. Course Work (PCW) program, in respect of
 - Admission to the Program (to be displayed on website)
 - Display of Admitted students list on the website
 - The Intake to the PCW program shall be limited to sixty only. The CCC shall have discretion increase the number of batches, if required with the prior permission of authority.
 - Display of Time Table for conduct of PCW
 - Arrangement of Resource Faculty for conduct of Program
 - Identification of Hall for conduct of Course Classes with necessary teaching aides
 - Attendance Monitoring (Min. 75% attendance)

5.0 PCW Examination

- 2. Paper 4 and 5 shall be supervised & evaluated by the concerned Supervisor/ Co-Supervisor at the respective research centre only. In Paper 4, the philosophy behind the proposed work, hypothesis and research methods to be adopted in the work shall be studied. Various academic activities like preliminary field visit/site visit/industry visit may be taken and comprehensive report shall be submitted by the candidate. However, the Paper 5 shall concentrate on exhaustive survey of literature in the specific domain area and preparation of a Review Paper. A seminar also shall be delivered by the candidate on Paper 5 work.
- 3. The Marks so obtained in Paper 4 and 5 shall be submitted to the A. R. (Confidential), in soft-copy as well as hardcopy, in the prescribed format only.
- 4. The examinations for the Papers 1, 2 and 3 shall be conducted by the University atleast twice in a year.
- 5. The Panel of Examiners shall be recommended by the CCC with the approval of Hon'ble Vice-Chancellor. The question paper of Paper 1 (Research Methodology) shall be in English & Marathi languages while paper 2 & 3 will be in English only.
- 6. The result in Consolidated Memo of Marks (CMM) shall be shown as PASS or FAIL with total aggregate 55%. Only subject wise marks (that too if not exempted) shall be shown in CMM and total marks shall not be printed. There will be no revaluation.
- 7. The PCW Registration Form shall be available on University Website. The Candidates can fill & submit it online with the prescribed fee. Else, the PCW Registration Form may be downloaded from the website and duly filled hard copy may be submitted along with the prescribed fee through their respective research centre.
- 8. The Examination shall be conducted as per schedule circulated by the University.
- 9. The CMM shall be passed on to the Candidates, through their respective research centre.
- 10. The PCW Paper 1, 2 and 3 exempted candidates shall be exempted from payment of University prescribed Course fee.
- 11. The Candidates shall be allowed to undertake six attempts to clear external papers i.e. Paper 1, 2 and 3.
- 12. However, Candidates shall pay re-examination fee prescribed by the University, irrespective of the number of exempted Papers.
- No Candidate shall be allowed to submit the thesis unless CMM or PhD Course Completion Certificate is attached.
