Administrative leadership in the University system is the force which guides the University as a whole. Administrative positions at senior level are vested with the responsibility, whether derived by statute, charter or articles of incorporation, for ensuring that the institution and its members fulfil their educational, social and ethical mandates. Administrative leaders may or may not be leaders in either teaching or research but are respected for their judgement, institutional knowledge and predictive powers. Such individuals are usually drawn into the institutional structure through appointment to senior administrative positions. Historically, the role of the administrators has tended to focus on the responsibility in functional areas such as administration, planning, finance, student welfare, and reporting. Some of the important skills required for Administrators can be identified as leadership qualities, communication skills, human resource management, financial management etc.

All Central Autonomous Bodies are required to balance between social objectives and the mainstream functions for which they are formed on one side and the rules & regulations of the government and other regulatory bodies. They also need to keep pace with the changing socio-cultural environment and technological developments. To ensure transparency in their operation, efficiency and sustainability in their activities and programmes, a good knowledge and understanding of the various administrative procedures, accounting systems and financial management are required. This necessitates a good exposure in both conceptual and practical aspects of accounting, financial management and general administration tuned for the autonomous bodies for their sound governance.

PARTICIPANTS PROFILE:-

- Assistant Registrar/ Section Officers or equivalent Officers working in the University/ Institutes (fully funded by the Central/State Government) may attend this 4 week online training programme.
- The programme has been divided into two distinct modules i.e. "Administrative Management" and


