Financial Bid shall be enclosed in Envelope No. 2 Both the sealed Envelopes shall be kept in envelope No. 3 which is big enough to contain both the envelops. On each envelope the name and address of the firm shall be written in block letter. On the top of its, the envelope Number should be mentioned.

- 01. The Vice Chancellor, Gondwana University, Gadchiroli is inviting expression of interest (EOI) in English in the enclosed format from experienced Chartered Accountant Firms empanelled with the Comptroller & Auditor General of India for appointment as Auditors for Annual Accounts Audit of F.Y. 2023-24. Your experience of interest could form the basis for a contract between your firm and Gondwana University Gadchiroli.
- 02. The objective of inviting expression of interest is to appoint the auditors through a wider reach and by a transparent process providing equal opportunity. Interested firms may please complete the enclosed Capability Statement Annexure 1 and send the same to the following address:

- 03. Vice Chancellor, Gondwana University, Gadchiroli reserves the right to reject any and all proposals received in response to this invitation in any manner deemed to be in the best interest of Gondwana University, Gadchiroli. Although, it is Vice chancellors, Gondwana University, Gadchiroli preference to award Contract for the services described in this invitation.
- 04. This invitation contains no contractual offer of any kind. Any proposal submitted will be regarded as an expression of interest by the proposes and not an acceptance by the proposer of any offer by Vice chancellor, Gondwana University, Gadchiroli. No Contractual relationship will exist except pursuant to a written letter of award signed by Registrar, Gondwana University, Gadchiroli and the proposer.

- 05. Vice chancellor, Gondwana university, Gadchiroli reserves the right to modify or exclude any consideration, information or requirement contained in this invitation and to add new considerations, information or requirements at any stage of the procurement process, including negotiations with proposers, at any time before any letter is awarded fo the audit services outlined in this invitation.
- 06. Gondwana University, Gadchiroli may, at its discretion, extend the deadline for the submission fo EOIs. The extension of the deadline may accompany a modification of the invitation documents prepared by GUG at its own initiative or in response to a clarification requested by a prospective proposer. Proposers must provide all requisite information under the EOI and clearly and concisedly respond to all points.

07. Eligibility, requirements and assessment Criteria:

The EOI and capability will be assessed against evidence of qualified and experience in providing annual Accounts Audit services in Gadchiroli.

The minimum Eligibility requirements are :-

- Professional Standing of the CA Firm: Minimum 15 years (as on Jan 2023 (CA Institute Certificate as on 01.01.2023)
- 2) Minimum no of partners: 05(Minimum 4 FCAs and of which at least two partner must have standing of more than 15 years)
- 3) Preference will be given to those firms. Who have minimum 10 years (as on Jan 2023) (CA Institue Certificate as on 01.01.2023) experience of annual account audit of turnover above 5 crore of state government universities.
- 4) Chartered Accountant firms must have minimum number of 15 qualified/semi qualified employees. Employees Adhar card details should be submitted.
- 5) Office Location: Vidharbha Region
- 6) Average Gross fees of the CA firm during FY 2020-21, FY 2021-22, FY 2022-23 Rs. 75.00 Lacs.
- 7) C & AG Acknowledgement for empanelment for FY 2023-2024.
- 08. The EOI should be sent along with a Capability statement including a profile of the organization relevant technical and geographical coverage along with the financial turnover for the last 3 financial years. A format(Annexure-2) for the capability statement is attached. Individual CVs are not required at this stage. Any EOI with inadequate information, those which do not meet the above criteria, or those received after the closing date will not be short listed. EOI should be as concise and focused as possible to give evidence of the above requirements including the capability statements and organization profiles.
- 09. In the interests of equity of treatment, EOI will be processed strictly as per prescribed formats enclosed. Non adherence to the formats shall lead to rejection of such EOIs. Further correspondence in respect of non standard EOIs will not be entertained.
- 10. EOI Annexure -1 should reach us on or before DUE DATE and TIME in a sealed cover duly super-scribed with "Annual Accounts Audit of F. Y. 2023-24" and "DUE DATE". Technical Bid (Envelope 1) of EOI will be opened first on and qualified firms on the basis of that will be informed about the date of the opening of financial Bid(Envelop 2). Responses received after due date and time shall not be accepted and no further correspondence on such responses shall be entertained. Gondwana University, Gadchiroli will not be responsible for any loss or delay in receipt of EOI in post.

LATE EOI SHALL NOT BE OPENED AND SHALL NOT BE CONSIDERED.

- 11. It is expected that the audit will be undertaken in accordance with the audit standard issued by the ICAI to the extent they are applicable to the given scope.
- 12. The financial quote should also be submitted in a separate envelope including out of pocket expenses if any and stating the taxes as applicable(Financial Bid Envelope -2)(Annexure-3)
- 13. Respondents, if desire, may participate in EOI opening after producing authorization / identity proof.
- 14. EOI submitted should be free from correction, over-writing, erasures etc., and each page should be suitably numbered.
- 15. Authorized signatory should sign the EOI submitted indication the name and designation with official seal. Unsigned EOI are liable to be ignored by Gondwana University, Gadchiroli.
- 16. Canvassing by respondents in any form, including unsolicited letters on EOI submitted or post corrections shall render their EOI submitted liable for summary rejection.

17. STATEMENT OF WORK

- 1) The scope of the Statutory Annual Accounts Audits will be provided to the short-listed firms. However, the Annual Accounts Audit is expected to be based on sufficient verification of the aspects covered in the scope of audit and not be on mere confirmation obtained from the Finance and other departments, like NSS, STRC, TRICEF, Exam., Model Degree College & other Projects of Gondwana University, Gadchiroli.
- 2) To file & do complete processes in Income Tax return of the university and various related services Also, TDS working and calculations for various TDS forms like 24Q, 26Q, & others. Generation of form 16 as and when required.
- 3) To file & do completed processes in GST return of the university and various service renders.
- 4) To complete the compliances of AG audit paras and make necessary process to resolve the A G compliances and issues.
- 5) To issue Utilization certificate of various funding agencies.
- 6) To take necessary action to complete the pending cases of Income Tax & GST. As per cases, Appeal to be done appropriate time if situation arises.
- 7) To do all Income Tax & GST related compliances, appeals, applications as and when required from time to time in the interest of Gondwana University, Gadchiroli.
- 18. Your EOI and Financial quote will be valid for 30 days from the deadline for submission Gondwana University, Gadchiroli will make its best effort to select a firm within this period.
- 19. The costs of preparing an EOI proposal and of negotiating a contract are not reimbursable by Gondwana University, Gadchiroli.
- 20. The cost of Annual Audit Fees remain same for period of Two year from F. Y. 2023-24(please quote the Rate Annual Audit Fees for F.Y. 2023-24)
- 21. The Tenure of contract period is Two year from F. Y. 2023-24

- 22. Gondwana University, Gadchiroli will not return EOIs received. These proposals shall be kept confidential for the sole and internal consideration of Gondwana University, Gadchiroli. Information relating to the examination, evaluation, and comparison of EOI proposals, and the recommendation of contract award, shall not be disclosed to proposers or any other persons not officially concerned with such process, even after publication of the contract award. Any effort by a proposer to influence Gondwana University, Gadchiroli in the examination, evaluation and comparison, of the proposals or contract award decisions may, at Gondwana University, Gadchiroli s decision, result in the rejection of its proposal.
 - Gondwana university, Gadchiroli shall not discuss the content of other proposals and how they compare to the proposers submission.
- 23. Gondwana University, Gadchiroli shall Endeavour to provide responses to any clarifications in an expeditious manner, but any delay in such response shall not cause an obligation on the part of Gondwana University, Gadchiroli to extend the submission date of the proposals, unless Gondwana University, Gadchiroli deems that such an extension is justified and necessary.
- 24. Disregard of any instructions may result in EOI being ignored.
- 25. Gondwana University, Gadchiroli looks forward to receiving your EOI and thanks you in advance.
- 26. The minimum Audit fees would be Rs. 1 lac (Plus GST) per year of engagement.
