
The scope of work on IUMS has been further divided into 5 modules herein as:

Subject – In response to the Resolutions to the Meeting held on 25<sup>th</sup> March 2019 in Mantralaya

Sir / Madam,

1. As you are aware that an Integrated University Management System ("IUMS") is under implementation across the 14 non-agricultural state universities of Maharashtra with an objective to aim to help these universities become end user friendly educational organizations which are efficient and resilient across their functions. In pursuance of these objectives, an Agency to Design, Develop / Customize, Implement & Maintain an Integrated University Management System across 14 State Universities of Maharashtra was selected through the bidding process.

The scope of work has been further divided into 5 modules herein as:

- **Student** Takes care of the entire lifecycle of the Student right from Admissions to examinations to result processing
- College /University This module takes care of the entire lifecycle of affiliation process right from college registering to it getting affiliated to the University
- Administration This module handles all the finance related activities at the Universities
- Faculty Takes care of the entire lifecycle of the employee at the university right from their eservice book to their attendance and leave management





- Academic This module caters to the academic calendar and the PHD students on Thesis & Research management
- 2. As part of IUMS Project, system Integrator (SI) will provide end to end services which include gathering of requirements from Universities, customization of modules based on requirements gathered, user acceptance testing (UAT) at each university with actual data to understand the gaps, making changes to system (if any) post UAT and moving system to go-live production stage post training of the users. The work of SI would also include all the data migration related activity for migration of legacy data from old systems to new system.
- 3. Further, the SI team will provide continuous support for a period of atleast 5 years post go-live, which is extendable beyond a period pf 5 years as well. For the purpose pf on-site support post go-live three (3) support persons for every 50 colleges from respective university shall be deployed throughout the contract period of 5 years who can perform onsite visit to the concerned college / university if required. In addition to this there will be a helpdesk support having a toll-free number on which the University / college can call up and have their issues resolved through a ticketing process.
- 4. With regard to financials of the project, it is stated that the overall cost of customization of application would be borne by the department of Higher and Technical Education fully.
- 5. In addition to above, annual convenience fee of Rs 31.8/- per student per year would be charged to students by the System Integrator through MahalT for the period of 5 years, after the implementation and go —live of the project. Further annual

convenience fee of Rs 17738.22/- per college per year would be charged to colleges by the System Integrator through MahaIT for the period of 5 years, after the implementation and go –live of the project.

6. In case of extension of contract beyond a period of 5 years, an annual convenience fee of Rs 39.74/- per student per year would be charged to students and annual convenience fee of Rs 22169.23/- per college per year would be charged to colleges respectively.

7. In view of the scanning and digitization (On screen marking) being available with some of the Universities it has been kept optional for the Universities however if any university wishes to opt for the OSM vendor provided by the System Integrator, annual student examination fee (For providing scanners, manpower for scanning and performing scanning and upload of answer sheet related activity for On screen Assessment / Digital Assessment of Answer sheets – for both semesters) of Rs 27.5/-per answer booklet per student will be charged.
