

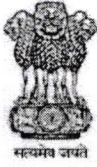

You are also requested to advise the officials/faculty members of your university/Institute to be more sensitive while dealing with incidents of caste discrimination, and provide the information as per the prescribed format, **within 7 days** on the University Activity Monitoring Portal (UAMP) of UGC at link <https://ugc.ac.in/uamp/> urgently.


- The Officials/faculty members should desist from any act of discrimination against SC/ST students on grounds of their social origin.
