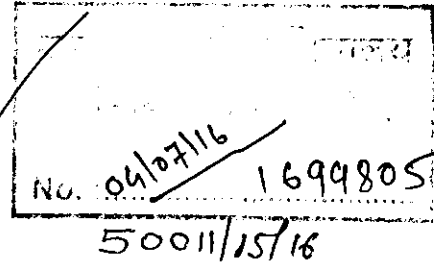

- This should be treated as essential for transparency and for service to all the stakeholders.



### **Executive Summary**

We carried the study in three phases in 2012, 2013, and 2016 to find how the state universities use the websites to communicate with students, parents, teachers and other stakeholders.

### **Essential Attributes**

We compiled data on the 12 essential attributes which were common in three top world universities, namely Massachusetts Institute of Technology, University of Cambridge, and Harvard University.

Following were some important observations from the study:

- None of the state universities in Maharashtra contained a section for parents/guardians
- Many universities do not have links to the social networking sites
- Regular updates of the websites were absent in many universities
- Most did not have adequate Marathi contents
- Many universities do not have features like search, web site maps, web masters, feedback, and campus map. At least four universities did not provide profiles of their faculty.

### **Attitudes and Responses to emails from the university staff**

We studied attitudes of the university staff while responding to the queries that parents emailed to them about points such as admissions to the courses. We used email addresses displayed in the Contact Us sections of the Websites of the universities, and of their departments.

- We sent electronic letters with specific queries to email addresses of the heads of departments and their colleagues.
- Data on the responses from 1270 members of the universities have been analysed. Of these, 205 mails bounced, and only 136 replied to the queries. Remaining did not respond.
- We found that many members of the staff were indifferent and or were casual while attending to the queries. Some wrote incorrect English and did not observe email etiquettes.
- Most top executives did not respond to the emails.
- We came across instances also of courteous writings by some staff. In some cases, the faculty attended to the queries even when it was not their responsibility to respond.

I suggest the Maharashtra government's Ministry of Higher Education, UGC, or Union Ministry of Human Resource Development should evolve guidelines for the academic institutions to set up websites of universities, colleges and other educational institutions.

**These guidelines are required because the existing rules cover only the technical issues.**

These ignore the essential attributes that would take care of interests of all the stakeholders, such as students, parents/guardians, teachers and non-teaching staff. There has to be a mechanism to ensure that essential attributes are covered in the websites.

About me:

**Dr Kiran Thakur:** I was a journalist for over three decades after which I joined academics in the year 2000. I retired as Professor and Head, Department of Communication and Journalism, University of Pune in 2007, and worked with Mudra Institute of Communications Research, Ahmedabad. My doctoral research was on online journalism and have completed two Major Research Projects funded by the University Grants Commission. The second project submitted earlier this month to the UGC related to Language of English Newspapers.

I have to my credit research papers presented at national and international conferences. My publications include a biography of Dr. N B Parulekar, Pioneer among Indian Journalists, Handbook of Print Journalists and one monograph titled: Websites of State Universities in Maharashtra which concerns topic of this letter.
