Examinations leading to the Degree of Bachelor of Pharmacy (Four Year – Eight Semester Degree Course) (Amendment) Direction, 2016

Whereas, Direction No. 124 of 2012 is in existence in the University in respect of Examinations leading to the Degree of Bachelor of Pharmacy (Four Year-Eight Semester Degree Course) Direction, 2012

AND

Whereas, it is provided under para 26 of the aforesaid Direction that "Notwithstanding anything to the contrary in this Direction, the Degree of Bachelor of Pharmacy shall not be conferred upon a person unless:-

The undergoes a practical training of not less than four weeks aftertaking the third year (Semester VII & VIII) B.Pharm. Examination in Pharmaceutical Industry/Primary Health Centre/Private Hospitals with 20 bed capacity and medical shop (Whole sale or Retail) approved by the Head/Principal and unless the Head/Principal certifies that the person has satisfactory completed the said practical training, as the case may be".

AND

Whereas, Dean of faculty of Medicine (including pharmaceutical science) and the Chairman of the Board of Studies in Pharmaceutical Science in the faculty of Medicine in their meeting held on 15-10-2015 in the University at 1.00 p.m. vide item no. 4 has resolved as follows:

'It was decided to include Industrial/Practical training in Direction of Pharmacy (Direction No. 124)

AND

Whereas, Dean, faculty of Pharmaceutical Science vide letter dated 06-08-2015 has communicated to the Asstt. Registrar (Acad.) that he has already decided the matter in the Board of Studies meeting held on 05-08-2015 as mentioned below –

"The Degree of Bachelor of Pharmacy shall not be conferred upon a person unless:-He/she undergoes a practical training of not less than eight weeks after taking the third or final B.Pharm. examination in pharmaceutical concern approved by the Head/Principal and unless the Head/Principal certifies that the person has satisfactory completed the said practical/Industrial training as the case may be".

Whereas, Direction No. 124 of 2012 has not been converted into an Ordinance".

Whereas, the matter mentioned at above para is to be provided in the sub ordinate legistation relating to B.Pharm. course.

AND

Whereas, it is expedient to amend the existing Direction No. 124 of 2012 for including the above said provision in it.

Now, therefore, I, Dr. N.V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in expercise of the powers vested in me under provision of sub-section (8) of section 14 of the Maharashtra Universities Act, 1994 do hereby issue following Directions to amend existing Direction No. 124 of 2012.

- 1. This Direction may be called "Examinations leading to the Degree of Bachelor of Pharmacy (Four Year Eight Semester Degree Course) (Amendment) Direction, 2016.
- 2. This Direction shall come into force from the Academic Year 2016-2017 for the students to be admitted to Vth Semester of Bachelor of Pharmacy Degree Course.
- 3. Sub-Para of Para 26 of Direction No. 124 of 2012 in respect of "Examinations leading to the Degree of Bachelor of Pharmacy (Four Year-Eight Semester Degree Course), Direction, 2012" be substituted by the following sub-para.

"He/she undergoes a practical training of not less than eight weeks after taking the third year (Vth & VIth semester) or the final year (VIIth & VIIIth semester) B. Pharm. Examinations in the Pharmaceutical concern approved by yhe Head/Principal certifies that the person has satisfactory completed the said practical/Industrial training as the case may be.".
