Dear Sir,

With reference to above, for applying or sending proposals online under any schemes, pre-requisite for a College is to register itself on the portal as user. It has been observed to the UGC that a major difficulty is being encountered with respect to college registration.

The colleges can use e-scheme portal only after their registration is authenticated by CPP-1 Section at UGC Head Office. Most of the colleges which have registered so far have not been approved by CPP-1, as the data entered by them pertaining to name, address, affiliated university, aided/unaided status, teaching level UG PG is not matching with the data available with CPP-1 Section. This may have happened as the colleges have not got the changes updated in CPP-1 records.

In view of the above it is requested to please get the data of your college updated in UGC records, as per herewith enclosed the details of the documents required and by writing to CPP-1 Section at UGC headquarter on giving address.

The UGC has initiated e-governance. Under this, a portal "e-schemes" has been prepared and the same is available on the home page of UGC website <a href="www.ugc.ac.in">www.ugc.ac.in</a>. At present a few schemes have been made online using "e-schemes" portal and gradually other schemes will also be made online. For applying or sending proposals online under any schemes, pre-requisite for a College is to register itself on the portal as user.

It is observed that a major difficulty is being encountered with respect to college registration. Colleges can use e-scheme portal only after their registration is authenticated by CPP-I Section [inclusion of colleges u/s 2(f)/12(B)] at UGC Head Office. Most of the colleges which have registered so far have not been approved by CPP-I, as the data entered by them pertaining to name, address, affiliated university, aided/unaided status, teaching level (UG/PG) is not matching with the data available with CPP-I Section. This may have happened as the colleges have not got the changes updated in CPP-I records.

You are, therefore, requested to advice all the colleges under your jurisdiction to get the data in respect of their colleges updated in UGC records, by writing to CPP-I Section at UGC Headquarter on the following address:-
