Dear Sir/Madam,

UGC Regulations on (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulations, 2010 dated 30th June, 2010 were notified in the Gazette of India on 18th September 2010. Clause 5.6.1 (d) of these Regulations has been amended vide UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulations (4th Amendment), 2016 which provides as under:-

"The term of appointment of the College Principal shall be five years with eligibility for reappointment for one more term only after a similar Selection process which shall take into account an external peer review, its recommendations and its outcomes. The framework of the external peer review shall be specified by the UGC."

The matter was considered by the Commission in its meeting held on 15th November, 2016 and as per decision of the Commission, the constitution of the External Peer Review Committee shall be as under: -

Nominee of the Vice-Chancellor of the affiliating University (i)

Nominee of the Chairman, University Grants Commission

The nominees shall be nominated from the Principals of the Colleges with Excellence /College with Potential for Excellence / Autonomous Colleges / NAAC 'A+' accredited Colleges.

The Report of the above Peer Review Committee shall be the main basis for re-appointment of the Principal.

You are requested to please take note of the above and ensure compliance of the same.
