Subject : Regarding time limit for submission of Completion documents of XI Plan Building Projects.


Sir/Madam,

This is with respect to subject cited above. In this regard, it is to inform you that UGC, New Delhi vide Letter No. No. F.18-3/2016(Misc./WRO/RO) dated 01.03.2018 has directed to "admit and settle all claims of building projects pertaining to XI Plan period latest by 30.04.2018 and requested to intimate all the colleges under jurisdiction of UGC (WRO), Pune to submit their claims of building projects pertaining to XI Plan period latest by 31.03.2018 with all supporting documents so that their claims can finally be settled. It may also be noted that expenditure, if building whose construction started on or before 31.03.2012 would be admitted only up to 31.03.2015 as already communicated vide letter No.F.18-5/2016(CRO/Misc./RO) dated 01.03.2016".

Kindly ignore, if no building projects were sanctioned during XI Plan. However, pending cases of building projects of XI Plan must be finalized immediately as per above failing which no grant will be released under any UGC schemes henceforth.

Kindly treat the matter as Urgent and adhere to the stipulated deadline.


Sir/Madam,
