- Whereas, in exercise of the powers, conferred under the Disaster Management Act 200 the undersigned, in his capacity as Chairperson, State Executive Committee has issued Order dated 30th September, 2020 and 14th October, 2020 (extended by order dated 2th October, 2020 and 27th November, 2020) for containment of COVID-19 in the State, for period upto 31st December, 2020 and issued revised guidelines by including certain activit from time to time vide above mentioned orders.

Whereas the State Government is satisfied that the State of Maharashtra is threater with the spread of COVID-19 virus, and therefore to take certain emergency measures prevent and contain the spread of virus, the Government in exercise of the powers confer under Section 2 of the Epidemic Diseases Act, 1897, read with all other enabling provisi

of The Disaster Management Act, 2005, it is expedient to extend the lockdown in the entire State of Maharushtra further till 31st January, 2021.

Now, therefore, in exercise of the powers conferred under Section 2 of the Epidemic Diseases Act, 1897 and the powers conferred under The Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, hereby issues directions that the guidelines issued vide orders dated 30th September, 2020 and 14th October, 2020 (extended by order dated 29th October, 2020 and 27th November, 2020) to operationalize MISSION BEGIN AGAIN for easing of restrictions and phase-wise opening, will remain in force till 31th January, 2021 for containment of COVID-19 epidemic in the State and all Departments of Government of Maharashtra shall strictly implement these guidelines. The activities already allowed and permitted from time to time shall be continued and all earlier orders shall be aligned with this order and shall remain in force up to 31th January, 2021.
