

About the Competition

Present RSS Chief Shri Mohan Bhagwat is elder son of Late Adv. MadhukarraoBhagwat. Adv. RavindraBhagwat who is a youngest Son of Late Adv. Moot Problem

Indistan is a Sovereign, Socialist, Secular and Democratic Republic governed by the written Constitution. The Constitution in its Preamble promises equality of status and opportunity to its citizens and further admits Right to Equality a status of Fundamental Right. The Constitution also grants permission to the State to make special provisions for certain weaker sections of the society viz. includes Socially and Educationally backward classes. The Supreme Court of Indistan in exercise of its authority to interpret Constitutional provisions laid down that the upper limit of this reservation is 50% and State is not entitled to make provisions for any reservations beyond this limit. Recently, Parliament of Indistan passed a Constitutional (103rd Amendment) Act, 2019 thereby providing 10% reservations to economically weaker sections of the general classes of people, who were not covered under the earlier scheme of reservation. The petition therefore is filed by the NG) called 'Equality for All' before the Supreme Court of Indistan challenging the Constitutional validity of the said Amendment.

Note: The Constitution of Indiastan and the system established thereunder is same as that of Indian Constitution.
