Guidelines to Author

Authentic, scholarly and unpublished research papers are invited from scholars / faculty / researchers / writers / professors for the **'Annals of Gondwana'** a Multidisciplinary and Multilingual Peer Reviewed (Bi-Annual) Research Journal with ISSN.

The Publishing Team of the **'Annals of Gondwana'** suggest you to not to submit same article to the multiple journals simultaneously. This may create a problem for you. Please wait for review report, which will take a maximum period of 60 days (about 2 months). All authors are hereby informed that the paper once accepted cannot be withdrawn at any condition.

Review Process:

All research papers submitted to **Annals of Gondwana** shall be reviewed by Peer Reviewed Committee Experts and Editorial Board.

Manuscript Submission:

The work which is neither published before nor under consideration for publication anywhere else can be submitted for publication to this journal. The publication must be approved by co-authors and authorities wherever applicable. The publisher shall not be held legally responsible arise out of copy right issues or for any claims for compensation, if arises.

Online Submission:

Authors must send their manuscripts by email. The email address for submission of Manuscripts annalsofgondwana@unigug.ac.in.

Permission:

Authors wishing to reproduce any figure, table or text of another source are required to obtain permission from the copyright owner(s). Such permission evidence should be included while submitting the research article to this journal.

Types of Manuscripts:

* **Full length research papers:** These research papers should not have more than 08-10 type written pages including figures, tables and references. (Word limits 3000)

* **Short communications:** These communications should not have more than 04-06 type written pages including figures, tables and references (Word limits 1500).

* **Case studies:** The case studies should not have more than 06-08 type written pages including abstract, keywords, figures, tables and references (Word limits 2000).

Preparation of Manuscript:

Manuscript submitted to 'Annals of Gondwana' should be structured in the following manner.

Title page: It should include:

a) Concise and informative title (Size 14 in Times New Roman, Words-not exceeding 40).

b) Name(s) of the author(s) represented by superscripts with affiliation and addresses of all author(s).

e.g. Indu A. George^a, Bindu S. Maurya^b and Ramjan M. Mulani^b

The email address, telephone and fax numbers of the corresponding author should be given.

Abstract:

The abstract should not have more than 200 words for a full-length paper and 100 words for a short communication. Also, the abstract should not have any undefined abbreviations or unspecified references.

Keywords:

Please supply 4-5 keywords which can be used for indexing purpose.

Text:

For full length papers, text should be divided into following sections Introduction, Materials and Methods, Results, Discussion, Acknowledgements and References (Use normal plain font of 12-point Times New Roman for text). Automatic page numbering should be used.

For short communication, there should not be any heading except Abstract, Keywords, Acknowledgements and References.

Acknowledgements:

Acknowledgements of people for any technical help and funding agencies for financial support should be in separate section before references. The names of funding agencies should be given in full.

References:

Only works cited in the text should be included in the references. Reference list should be alphabetized in the last names of the first author of each research paper.

Figures:

- Each figure should be given in separate file.
- All figures should be cited in the text in consecutive numerical order.
- Figure parts must be denoted by lowercase letters (a, b, c.... etc.).
- Each figure should have concise and informative caption.
- The captions for the figures should be placed at the end of the text in the manuscript file.

Permissions:

Authors wishing to include figures, tables, or text passages that have already been published elsewhere are needed to obtain permission from the copyright owner(s) for both the print and online format and to include evidence that such permission has been granted when sending their papers. Any material received without such evidence will be assumed to originate from the authors.
