## ORDINANCE NO.101 OF 2017

## EXAMINATIONS LEADING TO THE DEGREE OF BACHELOR OF FASHION DESIGN (THREE YEAR DEGREE COURSE, SEMESTER PATTERN) WITH CREDIT GRADE SYSTEM, IN THE FACULTY OF HOME SCIENCE, ORDINANCE,2017

(Issued under Section 12(8) of the Maharashtra Public Universities Act, 2016.)

Whereas, it is expedient to amend an Ordinance No. 50 of 2017 in respect of Examinations leading to the Degree of Bachelor of Fashion Design (Three year Degree Course semester pattern) with credit grade system, in the Faculty of Home Science, Ordinance,2017 for the purposes hereinafter appearing The Management Council is hereby pleased to make the following Ordinance:-

- This Ordinance may be called "Examinations Leading to the Degree of Bachelor of Fashion Design, (Three year Degree course, semester pattern) with credits grade system, in the Faculty of Home Science, Ordinance, 2017."
- **2.** This Ordinance shall come into force with effect from the date of its making by the Management Council.
- **3.** In ordinance No. 50 of 2017 in respect of 'Examinations leading to the Degree of Bachelor of Fashion Design (Three year Degree course semester pattern) with credit grade system, in the Faculty of Home Science, ordinance, 2017':-

(i) in line 4 of para 4 . after the words and sign "recognized as equivalent thereto," and before the word "and" the following provision be inserted –

" candidates having two or three year Diploma of MSBTE in Dress designing and manufacturing or Diploma in garment technology or equivalent shall be given direct admission to 3<sup>rd</sup> semester of the course CGPA of the said examinees shall be calculated on the basic of the result of semester IIIrd, IVth, Vth and VIth for declairing the final year result and mention be made on the Marksheet as "Lateral admission."

## (Statement of object and reasons)

Two candidate were directly and mitted to the 3 rd semester of Bachelor of Fashion Design course at ad yadaorao Dhote Smruti Mahavidyalay, Rajura having Diploma in Dress Designing and Manufacturing.

The result of 6<sup>th</sup> semester of the said candidates was to be declared hence the matter was referred to the Board of studies in Home Science for guidance. The Board of studies has resolved to make provision in para 4 of Direction No. 151 of 2012 for these students regarding their direct admission to the 3 <sup>rd</sup> semester of the said course.

Recommendation of the Board of studies were placed before the meeting of the Academic Council held on 25/11/2016 vide Item No. 52 on the Agenda of the meeting and the Academic Council has approved the recommendations of the Board of studies.

In view of the resolution of the Academic Council, the Hon'ble Vice Chancellor has issued Directions under provision of sub section (8) of section 14 of the Maharashtra Universities Act,1994.

Direction issued by the Vice-Chancellor was required to be converted into an Ordinance hence Ordinance No. 50 of 2017 was to be amended. Draft Ordinance is prepared for amending Ordinance No. 50 of 2017.
