



**ORDINANCE NO. 18 of 2017**

**EXAMINATIONS LEADING TO THE 5 YEARS INTEGRATED DEGREE OF BACHELOR OF LAWS(B.A.LL.B) [CREDIT BASED SEMESTER SYSTEM] in the Faculty of Law, Ordinance,2017.**

**WHEREAS**, it is expedient to provide ordinance in respect of Examination leading to the 5 year integrated Degree of Bachelor of Law (B.A.LL.B) (credit based semester system) in the faculty of Law, for the purposes hereinafter appearing, the Management council is hereby pleased to make the following ordinance:-

1. This ordinance shall be called "Examinations leading to the 5 Years Integrated Degree of Bachelor of Laws (B.A.LL.B) (Credit Based Semester System) in the faculty of Law, ordinance, 2017.
2. This ordinance shall come into force from the date of its making by the Management council .
3. The duration of the programme is 5 academic years which spread over 10 semesters with the University Examination at the end of each Semester.
4. Each Academic Year shall be divided into Two semesters. The academic Session for Odd semesters (1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> & 9<sup>th</sup> ) will commence as far as possible from 1<sup>st</sup> of July, while for Even Semester (2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup>, 8<sup>th</sup> & 10<sup>th</sup> ) will commence from 1<sup>st</sup> of January every year.
5. An examination for each of the semester shall be held twice in a year at such places and on such dates as may be fixed by the Board of Examination. The fees for the examination shall be as prescribed by the University from time to time.

The courses/papers to this ordinance credits assigned to the each course and the scheme for examination shall be as given in the Appendix-I appended .

6. **Definitions of the Terminology** : the following are the definitions of the terminology used in the Ordinance:-

**(a) Audit Course:** Audit Course is not a compulsory course for completion of the programme. It is an extra-load course/paper (over the minimum number of required credits for the programme). Students who want to enroll in one or more courses for informational purposes may register for audit course. Grade of AU (audit) is granted to students who complete an audit course, but no credit is awarded. The marks sheet would indicate such extra papers as audit courses, but the AU grade obtained by the students would not be used for the calculation of SGPA & CGPA

**(b) Average Grade Letter** : refers to the Grade Letter awarded after summing up external and internal marks obtained in each course/paper.

**(c) Course** : It is equivalent to a paper/subject in a semester. It is a complete unit of learning which will be taught and evaluated within a Semester.

**(d) Credit** : Credit means the unit by which the course work is measured. It is measured in terms of weekly class hours assigned to a Course.

**(e) Credit Point (CP):** It is the value obtained by multiplying the Grade Point by the Credit i.e No. of Credits assigned for the course x Grade Points secured for that course.

**(f) Credit Transfer:** The credit acquired for the courses in another University would be accepted on reciprocal basis subject to the UGC Norms.

**(g) Cumulative Grade Point Average (CGPA):** CGPA refers to the Cumulative Grade Point Average weighted across all the semesters. It is obtained by dividing total number of credit points in all the semesters by the total number of credits in all the semesters.

**(h) Grade Point** : Grade Point is weight allotted to each grade letter depending on the marks awarded in a course/paper

- (i) **Grade Letter** : Grade Letter is an index to indicate the performance of a student in a particular course/ Paper. It is the transformation of actual marks secured by a student in a course/paper.
- (j) **Programme**: It means, in this particular context, a 5 year Programme of study and examination spread over Ten semesters, the successful completion of which would lead to the award of B.A. LL.B. (5 year course) degree.
- (k) **Semester Grade Point Average (SGPA)**: SGPA indicates the performance of a student in a given Semester. It is based on the total credit points earned by the student in all the courses and the total number of credits assigned to the courses/papers in a Semester.
7. **Eligibility Criteria for Admission**: (a) Admission to the programme shall be made on basis of merit by the respective college admission committee and in accordance with the rules and instructions provided from time to time by Bar Council of India. The reservation policy and rules of the Government of Maharashtra governing admission to higher educational institutions issued from time to time shall also be followed.
- (b) An applicant who has successfully completed 10+2 or Intermediate or equivalent from a recognized University of India or outside or from a Senior Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the B.A. LL.B. (5 Year Course) degree.
- (c) Students who secures minimum 45% of the total marks in the qualifying examination are eligible for admission into the programme. As per the Bar Council of India, New Delhi directions vide letter No. BCI:D:1379:2002(LE:Affln.), dated 2-8-2002, the 44.5% can be rounded off to 45%.
- (d) For S.C & S.T students, Minimum 40% of the total marks in their qualifying examination is required for admission into the Programme.
8. The medium of instruction and Examination shall be English. Question papers for the examination shall be set in English. However, the candidates will have an option to write their answers either in English, Hindi or Marathi.
9. Not with standing anything contained to the contrary, the intake capacity of each section in a class of 5 years B.A LL.B course shall be not more than 60 students.
10. No student shall be permitted to appear for the Semester Examination unless he/she has put in not less than 75% attendance of the classes held in any course/paper concerned including tutorials, moot court exercises, practical training etc. conducted in respect of that paper/course.

**11. Rules of Promotion: Rules of Promotion are as under:**

<b>Semester</b>	<b>Condition to be fulfilled for promotion</b>
<b>From I to II</b>	Should have appeared for atleast one theory paper in Semester-I
<b>From II to III</b>	Should have passed minimum 40% papers in Semester-I and minimum 40% papers in Semester II
<b>From III to IV</b>	Should have appeared for atleast one theory paper in Semester-III
<b>From IV to V</b>	Should have passed all papers of Semester I and Semester II

---

**AND**

Should have passed minimum 40% papers in Semester-III and minimum 40% papers in Semester IV

**From V to VI**

Should have appeared for atleast one theory paper in Semester-V

**From VI to VII**

Should have passed all papers of Semester I .II,III and Semester IV

**AND**

Should have passed minimum 40% papers in Semester-V and minimum 40% papers in Semester VI

**From VII to VIII**

Should have appeared for atleast one theory paper in Semester-VII

**From VIII to IX**

Should have passed all papers of Semester I .II,III ,IV, V and Semester VI

**AND**

Should have passed minimum 40% papers in Semester-VII and minimum 40% papers in Semester VIII

**From IX to X**

Should have appeared for atleast one theory paper in Semester-IX.

**12.** Each Semester shall comprise of not less than 18 weeks with not less than 30 class-hours per week including tutorials, moot room exercises and seminars, provided that there shall be at least 24 lecture hours per week.

- (a) A Class-hour shall consist of 48 minutes duration .
  - (b) The number of classes for theory / practical/Clinical courses per week must be equal to number of credits shown against the paper as indicated in the course structure or as indicated in the Appendix-I appended to this Ordinance.
  - (c) The Student who selected Major Subject in Social Sciences in 5<sup>th</sup> Semester are not permitted to change the same in subsequent Semester.
  - (d) Distribution of 20 marks for internal assessment, wherever there is a provision for internal assessment, shall be as follows:
    - (i) **First Internal Examination (Descriptive)** = 5marks
    - (ii) **Second Internal Examination (on-line/offline)**  
**with multiple choice questions** =5marks
    - (iii) **Seminars/Group Discussion** = 5marks
    - (iv) **Assignments/Viva-voce Examination** =5 marks
-

- (e) Each registered student shall have completed minimum of 12 weeks of internship during the entire period of legal studies under NGO, Trial and Appellate Advocates, Judiciary, Legal Regulatory authorities, Legislatures and Parliament, other Legal Functionaries, Market Institutions, Law Firms, Companies and Local Self Government.
- (f) The internship in any semester cannot be for a continuous period of more than Four Weeks and the internship programme will commence from 7<sup>th</sup> semester onwards. Each student shall keep internship diary in the form stipulated by the University and the same shall be evaluated by the Guide in Internship and also a Core Faculty member of the staff each time. The total marks shall be assessed in the Final Semester of the course in the 4<sup>th</sup> Clinical paper as stipulated in the Appendix-II appended to this ordinance.

**13. Evaluation System on the basis of Credit and Grade Pattern:** Based on his/her continuous evaluation, the academic performance of a student during a semester shall be graded on a Seven-point scale. The grade awarded to a student shall depend on his/her performance in external and internal examinations.

- (a) The academic performance of a student during a semester and at the end of the programme, shall be evaluated on the basis of:

- (i) Grade Point (GP) obtained in each subject**
- (ii) Semester Grade Point Average (SGPA),**
- (iii) Cumulative Grade Point Average (CGPA)**

- (b) Marks for Extra Curricular Components (E.C.C) are to be awarded in recognition of achievements in Sports/Cultural/N.S.S/NCC as per the rules and instructions of the University provided in this regard from time to time. These marks shall be added to improve the CGPA at the end of final semester i.e Xth Semester by multiplying the total marks obtained in E.C. C with 0.01.

**For Example:** A student gets a total of 12 marks in E.C.C and his C.G.P.A is 6.52. Then his total E.C.C marks i.e 30 shall be multiplied by 0.01 ( $30 \times 0.01 = 0.30$ ) and the result shall be added to C.G.P.A ( $6.52 + 0.30$ ). His final C.G.P.A will be 6.82

- (c) At the end of each semester examination, a student shall be awarded a Semester Grade Point Average (SGPA). A Cumulative Grade Point Average (CGPA) shall be awarded to each student at the end of Final Semester of the Programme. The details regarding method of calculating SGPA & CGPA is explained in detail in para 11.
- (d) Student who passed Audit Course shall be given 'AU' grade, while students who failed in Audit course will be given 'X' grade. However, these grades and marks in Audit Course shall not be considered for calculation of SGPA & CGPA.
- (e) Students shall complete the programme of B.A.LL.B (5 year Course) with eight consecutive years since their admission into First Semester .

#### **14. Awards of Grade Letter, Grade Points, Credit Points, SGPA, CGPA:-**

##### **(a) Award of Grade Letter and Grade Points:**

Each course/paper shall be valued in Seven Grades. The letter grades and their equivalent grade points are listed below. The marks shall show only Grade Letters and not Marks for each paper.

**(b) Calculation of Credit Points (CP):**-Credit Points for the course = **No. of Credits assigned for the course x Grade Point secured for that course.**

**(c) Semester Grade Point Average (SGPA):** SGPA indicates the performance of a student in a given Semester. SGPA is based on the **total credit points earned by the student in all the courses and the total number of credits assigned to the courses/papers in a Semester.** SGPA shall be rounded off to two decimal points. (e.g - 6.578 rounded to 6.58 & 6.574 will be rounded to 6.57)

$$\text{SGPA} = \frac{\text{Total Credit Points in the Semester}}{\text{Total Number of Credits for the Semester}}$$

Provided that SGPA is computed only if the candidate passes in all the courses (gets a minimum 'C' Grade in all Courses).

**(d) Cumulative Grade Point Average (CGPA) :** CGPA refers to the Cumulative Grade Point Average weighted across all the semesters. CGPA shall be rounded to two decimal Points (e.g - 6.578 rounded to 6.58 & 6.574 will be rounded to 6.57)

<b>CGPA =</b>	<b>Total Credit Points Obtained in all Semesters</b>	
	<b>Total Credits of all Semesters</b>	

Provided that CGPA is calculated only when the candidate passes in all the courses of all the semesters.

**15. Standard of Passing the Semester Examinations:** In order to qualify a particular examination, a candidate shall have to secure atleast 45% of marks in each and every theory and Practical/Clinical paper in each end semester examination and minimum of 45% of marks in internal assessment of each of the papers in which there is a provision for internal assessment. See for details Appendix-I. The same rule is also applicable to the Audit Course papers.

**16.** All the examees of University Examination including failures of examinations, shall be bound to study the Syllabus prescribed for a particular paper/subject/course as revised from time to time.

**17. Award of the Degree:** A student will be eligible for the award of B.A.LL.B (5 yrs) Degree only when he has successfully completed all the prescribed 60 courses with a total of 363 credits and obtained a minimum CGPA of 5.00 out of 10.00 and after payment of prescribed fee for receive a degree signed by the Vice-chancellor. **The result of the successful candidates shall be classified as follows:**

**18. Conversion of CGPA into Percentage of Marks:** The formula used in this ordinance to calculate percentage of marks from CGPA is

$$\text{Percentage} = 9 \times \text{CGPA}.$$

**19. Award of Medals and Merit Certificates:** Candidates who appear and pass the examination in all the papers of each and every semester at first appearance only are eligible for the award of Medals/ Prizes/Rank Certificates etc. The marks allotted for Extra Curricular Components shall be taken into account for deciding the inter se Merit as well as the award of medals .

### **(Statement of object and reasons)**

To regulate admissions, course structure and scheme of examination for the award of 5 years integrated Degree of Bachelor of Law (B.A. LL.B) based on credit scheme system, the Vice-chancellor of the University has issued Direction No.116 of 2012 dated 27/06/2012 under permission of sub-section(8) of section 14 of the Maharashtra Universities Act,1994 and to decide the capacity of each section/class for admission to each course of B.A.LL.B Degree, the Vice-Chancellor has issued Direction No.116 (A) of 2013 Dated 30/08/2013.

Above Mentioned two Directions are required to be converted into an Ordinance, hence this Draft ordinance has been prepared for consideration of the Academic council and the Management council of the University.
