Ordinance No 52 of 2017

Absorption of Failure/Ex-Students of all the courses (UG & PG) of RTM Nagpur University, Nagpur in Gondwana University, Gadchiroli for all the Faculties ordinance, 2017.

Whereas, it is expedient to provide an ordinance in respect of Absorption of failure/Ex-students of all the courses (UG & PG) of RTM Nagpur University, Nagpur in Gondwana University Gadchiroli for all the faculties for the purposes here in after appearing, the Management council is hereby please to make the following ordinance:-

1. This ordinance may be called 'Absorption of Failure/Ex-Students of all the courses (UG & PG) of RTM Nagpur University, Nagpur in Gondwana University, Gadchiroli for all the Faculties ordinance,2017;
2. This ordinance shall come into force with effect from the date of its making by the Management council.
3. Subject to his/her compliance with the requirements of this ordinance and of other ordinances in force from time to time, for absorption of failures/ex-students of all the courses (UG & PG) in Yearly/Semester Pattern of R T M Nagpur University, Nagpur in the equivalent courses (Yearly/Semester pattern with or without credit grade system) of this University, offered under the related faculty, candidates shall be absorbed as per the equivalence scheme recommended by the concerned Board of Studies.
4. This ordinance is made to give effect to the following decisions as applicable to the absorption of Failure / Ex-Students of RTM Nagpur University:-
 - a) The candidate shall be allowed to keep term in higher classes/semester in the relevant UG/PG course of the Gondwana University as per the provisions in respect of prescribed eligibility in the relevant ordinance of Gondwana University, Gadchiroli.
 - b) The student who has secured exemption in any subjects(s) at any level during the course of his studies at RTM Nagpur University shall get the benefit of exemption in the equivalent subject(s),provided the subject(s) is/are part of scheme and syllabus of respective UG/PG course offered by Gondwana University, Gadchiroli. This shall be applicable to both the heads of passing viz theory and practical.
 - c) However, they shall have to clear their subjects under ATKT of the previous qualifying examination of RTM Nagpur University in a maximum of TWO attempts during admitted current academic yea and further that such examination/s as per the relevant scheme & syllabus

prescribed by RTM Nagpur University shall be conducted by the Gondwana University, Gadchiroli.

- d) The students absorbed in this University for a particular level of qualifying examination shall be provided with equivalent Grade Sheet of this University for that level of examination only.
- e) During the course of study of such students and upon his/her subsequent absorption in this University at any level of examination, for a fresh subject(s) if any in the equivalent scheme and syllabus of this University, the candidate shall be required to pass by securing prescribed passing standard as applicable to those particular heads of passing. In the event, the college assessment (CA) in such theory subject(s) shall be the average of college assessment in remaining theory subjects of that particular semester only.
- f) However, the students shall be granted exemption in Practical/Laboratory, if any, existing in the absorbed pattern of curriculum. The total practical marks granted in such cases shall be 25 or 50% of respective theory subject out of 100, whichever is more, presuming that the maximum marks in practical are 50 only.
- g) The B.E.(Bachelor of Engineering) First Year of curriculum of RTM Nagpur University, Nagpur since having annual pattern shall be considered as I and II Semesters of one academic year (only during the session 2013-14) for the purpose of absorption in the equivalent degree course of this University.
- h) In view of this extra-ordinary facility granted by this University, the chances to pass in a particular examination as per the scheme and syllabus of RTM Nagpur University, Nagpur shall be as under:

It is made especially clear that under no circumstances, additional chance would be available to pass in an examination of RTM Nagpur University, Nagpur conducted by this University and that the failure students would be required to appear for the examination/s as per the absorption and equivalence scheme of this University without any deviation or relaxation.
6. Despite of this ordinance, if any candidate fails to take admission for completing his remaining course of the study, thereby not complying with various provisions made in this ordinance he/she shall have to seek fresh admission at appropriate stage of his/her course of study, be it in the semester pattern with credit grade system or Yearly Pattern of this University as per the relevant ordinances without any relaxation and /or exemption.
7. The students of RTM Nagpur University, Nagpur absorbed into the semester pattern with credit grade system of this University shall be awarded with the **'Degree'** as per the applicable rules.

8. This is to make clear in particular that, It is the duty and responsibility of the Principal/s of affiliated colleges/institutes to facilitate such students in respect of their inter-university Migration, ensuing eligibility of Gondwana University, legitimate admission/s at the appropriate semester/year of remaining course of their study, and rest of the applicable procedures as they pertain to their absorption in this University. It is further made clear that without seeking Migration for RTM Nagpur University, Nagpur in no case any such student shall be allowed to appear for the level of examination in which he/she is admitted at the respective college.
9. The Examinations recognized by this University so far, by ordinance shall be deemed to have been recognized as equivalent to the corresponding degree examinations of this University under this ordinance.
10. After the successful absorption of such students by this university till the Final Year of their course of the study at the respective colleges affiliated to this University, the various provisions of this ordinance as applicable to these students shall automatically stand ceased. It is further made clear that no further Notification shall be issued for withdrawal of this Extra-ordinary facility granted by this University which shall cease as shown below.

11. If any uncertainty arise in giving effect to the various provisions of this ordinance, the Controller of Examinations and Dean of the concerned Faculty shall give their decision with prior approval of the Vice-Chancellor for such a particular case if any which shall be final and mandatory to all the concerned.

(Statement of object and reasons)

Direction No.157(A) of 2013 was issued by the Vice-Chancellor on 31/7/2013 in respect of Direction prescribing absorption of failure Ex-Students of all the courses (UG & PG) of R.T.M. Nagpur University in Gondwana University, Gadchiroli for all the faculties from the session 2013-14 onwards ,under provision of section 14(8) of Maharashtra University Act, 1994.

The above mentioned Direction was to be converted in to an ordinance as provided under section 14(8) of the above mentioned Act, hence this Draft ordinance is prepared for consideration of the Academic- council and the Management council.
