



# **GONDWANA UNIVERSITY GADCHIROLI**

## **Ordinance No. 61 of 2017**

### **Procedure and qualifying norms for preparation of Examination wise Merit List and any other such Distinctions for all the Examinations offered under all the faculties, ordinance, 2017.**

**WHEREAS**, it is expedient to provide an ordinance in respect of Procedure and qualifying norms for preparation of Examination wise Merit List and any other such Distinctions for all the Examinations offered under all the faculties, for the purposes hereinafter appearing, the management council is hereby pleased to make the following ordinance :-

1. This ordinance may be called “Procedure and qualifying norms for preparation of Examination wise Merit List and any other such Distinctions for all the Examinations offered under all the faculties, ordinance 2015.”
2. This ordinance shall come in to force with effect from the date of its making by the management council.
3. By way of this ordinance , the University aims to promote and recognize academic excellence, constructive leadership and overall growth and development of students pursuing their course/s of the studies.
4. By this ordinance, notwithstanding anything to the contrary in any of the University ordinance, the qualifying norms for successful candidates at the University examination to become eligible for award of the degree and for his/her subsequent inclusion in the Merit List shall apply as mentioned in the respective ordinance of the given course of study.
5. The criterion for considering the eligibility of successful candidates at the University examinations for inclusion in the Merit list shall be as given below:
  - a) Based on marks secured and division, in case of courses with annual/yearly pattern.
  - b) Based on GPA (Grade Point Average in case of courses having a final (single) examination at the end of the given course viz annual/yearly pattern with Credit Grade System.
  - c) Based on CGPA ( Cumulative Grade Point Average) in case of Courses having more than one end semester examinations with Credit Grade System.
6. For considering the eligibility of successful candidates at the University examination for inclusion in the Merit list, the period for passing the University examination, i.e. the minimum period required for completion of the course shall only be taken into account. The period required for taking the examination of that course consecutively shall be counted as the

minimum period and even within that period the candidates shall neither have passed the examination (s) by examination nor shall have appeared at that examination in any previous years. Any previous failure at any examination within the course shall debar him/her from being considered for a place in the Merit list.

7. For publishing the number of places in the Merit list, the following criteria shall be followed :-

- a) If the number of candidates at any examination is 100 or less, only three places in the Merit list;
- b) If the total number of candidates is between 101 to 500, five places in the Merit list;
- c) If the number of candidates is 501 and to any limit, ten places in the Merit list.

8. For becoming eligible for inclusion in the Merit list, wherever it is prescribed in the ordinance even for the candidate with Second Division, it is a must for the candidate to have obtained at least pass score marks in the aggregate in one or more than one examination/s taken together, as the case may be.

9. In the event of two or more students being eligible for inclusion in the Merit List for the same place, the rank shall be given to one who is Younger or youngest in age.

10. The Merit List showing order of ranks secured by the given candidates for a particular examination shall suitably be notified from time to time by the competent authority of the University.

11. If any uncertainty arises in giving effect to the various provisions of this Ordinance, the Hon'ble Vice-Chancellor, Gondwana University, Gadchiroli shall decide upon for such a particular case if any which shall be final and mandatory to all the concerned.

#### **(Statement of object and reasons)**

The Vice-chancellor of the university had issued Direction No. 170 of 2014 on 11/12/2013 in respect of Direction prescribing Procedure and qualifying norms for preparation of Examination wise Merit List and any other such Distinctions for all the Examinations, under all the faculties, under provision of section 14 (8) of the Maharashtra university Act, 1994.

The subject matter of the Direction is required to be regulated by an ordinance as provided under the Act.

In view of the above, the existing Direction is required to be converted into an ordinance as provided under the Act, hence this Draft ordinance is prepared for consideration of the Academic council and the management council.
