Ordinance No. 90 of 2017

GONDWANA UNIVERSITY, GADCHIROLI GAZETTE ORDINANCE, 2017

Whereas, it is expedient to publish a pecriodical in the form of a Gazette of the Gondwana University, Gadchiroli, Gazette, for the pruposes hereinafter appearing the management council is hereby pleased to make the following Ordinanace.

- 1. This ordinance may be called "Gondwana University, Gadachiroli Gazatte, Ordinance , 2017"
- 2. This Ordinance shall come into force with effect from the date of it's making by the management Council.
- 3. In this Ordinance, unless the context otherwise requires:-
 - (a) "Act" means the Maharastra Universities Act, 1994 (Maharastra Act No.xxxv of 1994)
 - (b) "Column" means a column of the statement as given in Gazatte Register.
 - (c) "Gazatte" means publication of the Gondwana University, Gadchiroli in the form of a periodical styled as Gondwana University ,Gadchiroli Gazatte".
 - (d) Gazette Register" means a register maintained separately for each part, in the office to be published/ published in each part of the Gazette.
 - (e) "Registrar" means the Registrar appointed u/s 17 of the Act and includes the person authorized by him to carry out the purposes of this Ordinance.
 - (f) "Schedule" means the Schedule attached to this Ordinance.
 - (g) "Statement" means a statement given in Appendix "A" and which shall form a part of the Gazette Register.
 - (h) "University" means the Gondwana University, Gadchiroli.
- 4. Gazatte may be registered as a periodical with the Registrar of News papers and shall be published ordinarily on every Thursday or as and when necessary.
- 5. Gazette shall be divided into parts and subject matter to be included in each part shall be as prescribed in the Schedule.
- 6. The Gazette may be published either in the cyclostyled form or computerized form or in the printed form as may be convenient.
- 7. Page size of each page of each part of the Gazette shall be 8 1/2 x131/2 wherein size of a composed (if it is printed) matter shall be 72 x42 EMS.
- 8. If it is published in printed form, paper size of the Gazette shall be17©x27© that is to say one full sheet of a paper having size of 17©x 27© Each such sheet shall contain 8 pages i.e. 4 leaves of the Gazette consequently each page having a size mentioned in para 7 above.
- 9. Pages of each part shall be consecutively numbered from 1st January to 31 st December in each calendar year. Page number shall be in the following manner:-

Gondwana University Gadchiroli Gazette -2016 Part- ONE 102 or G.U.G. Gazette -2015-Part- ONE-102

- 10. Page numbering shall always be at the centre top of each page either above a thin black line or without such thin black line. Provided that on the title page of each part, page numbering shall be at the bottom (centre) below a thin black line or without such thin black line.
- 11. Title and the matter on the first page of each issue of each part shall be, as far as possible, in the following manner:-

First Line :- Gondwana University Gadchiroli Gazette-

Second Line :- Official Publication of Gondwana University, Gadchiroli.

Next Line :- Day.....and Date.....

(Seal of the Gondwana University, Gadchiroli if possible, may be displayed at convsenient place.)

- 12. After every quarter of the year index pages of each part may be circulated giving contents of the matter published in that part during that quarter. The index pages shall be separately numbered in separate style.
- The Registrar shall cause to maintain the Gazette Register in his office.
 There shall be a separate Gazette Register for each part.
- 14. No matter shall be published in the Gazette without the approval of the Registrar. Whenever any matter is to be published in the Gazette, Registrar shall cause to fill in the entries in column numbers 1 to 3 and shall also signify his approval in column No. 4 of the Gazette Register.
- 15. Annual subscription of each part may be as prescribed by the Management Council.

(Statement of object and seasons)

The University has to publish a periodical in the form of a Gazette. To regularise the said publication which is in parts, it is necessary to prepare a Draft ordinance to serve the purpose of the publication of the Gazette, hence this Draft ordinance is prepared for its making by of the Management Council of the University.
