Direction No.185 of 2016.

Examinations leading to the Degree of Master of Library and Information Science in the Faculty of Social Sciences (Two years Credit Based Semester system of integrated M.Lib.I.Sc Course Four semesters and B.Lib.I.Sc/M.Lib.I.Sc - I year credit based semester system Two semesters) (Amendment) Direction, 2016.

Whereas, The Maharashtra Universities Act. No. XXXV of 1994 (hereinafter referred to as the Act) has come into force with effect from 22nd July, 1994 and has been amended from time to time;

AND

Whereas the University Grants Commission New Delhi has suggested, vide D.O. Letter No. F- 2/2008 (XI Plan) 31st January 2008 to have academic reform in the universities in the area of examination reforms including continuous internal assessment, introduction of credit based courses, semester system etc. The Gondwana University, Gadchiroli has adopted two years (Four semesters) credit based semester pattern for the post graduate degree course in Master of Library and Information Science M.Lib.I.Sc., for improving quality of higher education in Library and Information Science;

AND

Whereas the board of studies in Library and Information Science, in its meeting held on 18.04.2012 at Gondwana University, Gadchiroli, has resolved to introduce the Master of Library and Information Science 2 years post graduate degree course on **Credit Based Semester Pattern** (Four semesters) and further recommended its continuation from the academic session 2012-2013 progressively;

AND

Whereas the Dean, Faculty of Social Sciences concurred with the recommendations of the Board of Studies in Library and Information Science on 09.05.2012 and requested the Vice-Chancellor to take appropriate action for implementation of the same from the academic session 2012-13;

AND

Whereas the Vice-Chancellor of Gondwana University, Gadchiroli approved the recommendations of the Board of Studies in Library and Information Science concurred by the Dean, Faculty of Social Sciences, for Master of Library and Information Science two years post graduate degree course on **Credit Based Semester Pattern** in four semesters on behalf of the Academic Council and the Management council under section 14(7) and syllabi for the same under section 38(a) of the Act;

AND

Whereas, Direction No. Acad/142 of 2012 was issued by the Vice-chancellor under provision of sub-section (8) of section 14 of the Act,

AND

Whereas, provision for admission to IIIrd semester of M.Lib.I.sc. course was made under clause (c) of para 06 of the above said Direction for the students who have passed B.Lib.I.sc. yearly pattern or semester pattern course.

AND

Whereas, provision for conversion of marks of B.Lib.I.sc. (yearly pattern course) into 1st and IInd semesters marks of M.Lib.I.sc. (semester pattern) course was not made in Direction No. Acad./142 of 2012;

AND

Whereas, the university has faced the difficulties while declaring the result of the students who were admitted to IIIrd and IVth semesters of M.Lib.I.sc. Examination having B.Lib.I.sc. Degree with yearly pattern or semester pattern;

AND

Whereas, for declaring the result of an examinee admitted to IIIrd and IVth semesters of M.Lib.I.sc. (semester pattern course), it is necessary to make provision in the existing Direction No. Acad/142 of 2012, for the same;

AND

Whereas, making an ordinance for the same purpose is time consuming process;

AND

Whereas, provision for the above said purpose is to be made in the existing Direction No. Acad/142 of 2012;

AND

Whereas, Direction No. Acad/142 of 2012 is required to be amended to resolve the matter mentioned under above paras;

AND

Whereas, the Board of Studies in Library and Information science in its emergent meeting held on 24/11/2015 has resolved to recommend solution to solve the problem facing the university;

AND

Whereas, the recommendations of the Board of studies in Library and Information science has been accepted by the Vice-chancellor under provision of sub- section (7) of section 14 of the Act on behalf of the faculty of social Sciences and the Academic council of the university;

AND

Whereas, the recommendation of the Board of Studies are required to be incorporated in the existing Direction No. Acad/142 of 2012;

AND

Whereas, Direction No. Acad/142 of 2012 is to be amended.

Now, therefore, I, Dr. N. V. Kalyankar, Vice – chancellor, Gondwana University, Gadchiroli in exercise of the powers conferred on me vide sub section (8) of section 14 of the Maharashtra universities Act, 1994 do hereby issue the following directions :-

- 1) This direction may be called “ Examinations leading to the degree of Master of Library and Information science in the faculty of social sciences (Two years) credit based semester system of integrated M.Lib.I.sc. course, Four semesters and B.Lib.I.sc./ M.Lib.I.sc. – 1 year credit based semester system, Two semesters (Amended) Direction, 2015.”
- 2) This Direction shall come into force with effect from the date of its issuance.
- 3) Clauses a), b), c), d) and e) of para 06 of Direction No. Acad/142 of 2012 in respect of Direction Governing the examinations leading to the degree of Master of Library and Information science in the faculty of social sciences (Two years credit based semester system of integrated M.Lib.I.sc. course Four semesters and B.Lib.I.sc./ M/ Lib.I.sc. – 1 year credit based semester system, Two semesters) be substituted by the following para :- Admission and Eligibility for the examinations :-
 - a) Subject to his compliance with provisions of this Direction, an applicant for admission to semester 1st Examination shall have passed the Bachelor degree examination of the university or of any other statutory university.

- b) An applicant who has passed 1st semester examination, failed 1st semester examination subject to ATKT rules, shall be eligible for admission to the examination of IInd semester.
- c) An applicant who has passed IInd semester Examination, failed IInd semester examination subject to the ATKT rules, shall be eligible for admission to the examination of IIIrd semester.
- d) An applicant who has passed B.Lib.I.sc. Degree examination based on yearly pattern or semesters pattern shall be eligible for admission to the examination of IIIrd semester. If the degree examination marks of the candidate are not based on credit Grade system, his/her marks of B.Lib.I.sc. Examination shall be converted into S.G.P.A. of Ist and IInd semesters, as per formula provided under para 30 of this direction and shall be mentioned on the statement of marks of IVth semester examinations "Direct admission or Lateral Entry to M.Lib.I.sc. IIIrd and IVth semester." Result of M.Lib.I.sc. shall be declared on the performance of IIIrd and IVth semesters Examinations.
- e) An applicant who has passed, or failed IIIrd semester examination subject to the ATKT rules, shall be eligible for admission to the examination of IVth semester.
- f) For award of B.Lib.I.sc. degree (Integrated M.Lib.I.sc. first year of Two semesters), the candidate should have to complete and pass in all theory papers and practical's of Ist and IInd semesters."
