## **Revised Guidelines for Recognition**

as

## "Institutions of Higher Learning, Research and Specialized Studies"

Post-Graduate Department of the University, PG Department in the Affiliated Colleges, Research Laboratories of Central / State Government shall apply for recognition of research Centre in the relevant subject/s in the prescribed format along with the prescribed fees, under following categories.

- Post-Graduate Department of Affiliated Colleges having at least one recognized Ph. D. Supervisor in the Department.
- ➤ Research Laboratories of Central / State Government within jurisdiction of the University area having Two scientists with Ph.D. degree.
- Gondwana University being newly established, herein after a "Associate Research Supervisor" is allowed to guide and conduct research. A Associate Research Supervisor is a recognized Research Supervisor of the University, who can associate himself with only one recognized Research Center with the permission of the Head of the recognized research center to carry out the research work in the subject and to accommodate the eligible research scholars. In this regard, the Associate Research Supervisor has to submit the declaration to the University that he/she has associated with only one recognized research center. A recognized research center can accommodate maximum of TWO such Associate Research Supervisors per subject.

Apart from above stated conditions, the institution(s) applying under above category shall have to comply with the following conditions:

- 1. Must have other academic administrative and supporting staff.
- 2. Must have required infrastructure and research promotional facilities.
- 3. Research laboratory/s with sophisticated instruments as required for research in the given subject.

- 4. Adequate space for research scholar/s, computational facilities with essential software/s, un-interrupted power and water supply.
- 5. Earmarked library resources including latest books, Indian and International journals, e-journals, extended working hours for all subject/s, adequate space for research scholars in the department/ library for reading, writing and for storage of their study and research materials.
