**DIRECTION NO. 7 of 2020**

**“Recognition of Post-Graduate Teachers in Post-Graduate Department  
in Colleges / Recognized Institutions Direction 2020”**

(Issued under provision of Section 12(8) of the Maharashtra Public Universities Act, 2016)

Whereas, the Maharashtra Public Universities Act, 2016(Maharashtra Act No. VI of 2017) has come into force with effect from 1st March 2017;

AND

Whereas, sub-section (1) of Section 33(1) of the Act empowers the Academic council to prescribe norms for recognition of any member of the staff of an affiliated college or recognized institution as a teacher of the university, in consonance with the norms of the University Grants Commission and the State Government;

AND

Whereas, sub-section (2) of Section 36 of the Act provides for the constitution of Board Deans;

AND

Whereas, clause (d) of sub-section (1) of section 37 of the Act, provides that the Board of Deans shall make recommendations to the Academic Council regarding the norms of recognition of Post-graduate teachers and research guides in colleges and recognized institutions;

AND

Whereas, clause (e) of sub-Section (1) of Section 37 provides that the Board of Deans shall grant recognition to the post-graduate teachers as recommended by the Research and Recognition Committee in accordance with the norms prescribed by the Academic Council;

AND

Whereas, sub-Section (1) of Section 29 of the Act provides that the Statute may be made for any matter which is to be prescribed or which is necessary to give effect to the provisions of the Act;

AND

Whereas, to give effect to the provision of clause (d) of sub-Section (1) of Section 37, it is necessary to make the Statute in this behalf;

AND

Whereas, making of Statute is a time consuming process;

AND

Whereas, no Statute is made in this behalf, hence it is necessary to issue the Direction in this regard under provision of sub-section (8) of section 12 of the Act, for the time being, to regulate the said matter.

Now, therefore, I, Dr. N. V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in exercise of the powers conferred in me vide sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016 do hereby issue the following Directions—

1. This Direction may be called, **“Recognition of Post-graduate teachers in Post-Graduate Department in colleges / recognized institutions Direction, 2020”**
2. This Direction shall come into force from the date of its issuance.
3. In this Direction unless the context otherwise requires;
  - a. “Act” means the Maharashtra Universities Public Act, 2016 i.e. Maharashtra Act No. VI of 2017.
  - b. “Academic Council” means the council constituted under sub-section(3) of section 32 of the Act.
  - c. “Board of Deans” means the Board constituted under sub-section(2) of section 36 of the Act.
  - d. “College” means a college conducted by the University or affiliated to the University situated in the University area.
  - e. “Post Graduate Department” means a department in the college or institution of higher learning, research or specialized studies, recognized to be so, by the university and imparting post-graduate instruction or guidance for research.
  - f. “Recognized Institution” means an institution of higher learning, research or specialized studies, other than college, and recognized to be so, by the university.
  - g. “Research and Recognition Committee” means the committee for each Board of studies constituted under provision of sub-section(a) of section 37(2) of the Act.
  - h. “Teacher” means full time approved Professor, Associate Professor, Assistant Professor, Reader, Lecturer, Librarian, Principal, Deputy/Assistant Librarian and Documentation Officer in the university and college Librarian,<sup>2</sup> [Principal, deputy or assistant librarian and documentation officer in the university and college Librarian,] Director or Instructor of Physical Education in any University Department, Conducted, Affiliated or Autonomous Institution or Department or recognized Institution in the University.
  - i. “Department” means a Department teaching a particular subject or a group of subjects in a college as prescribed in the statute.
  - j. “University Department” means a Department established and maintained by the University.
  - k. “University Department” means a centre, a school or an Institute established and maintained by the University.
  - l. “University” means any of the Universities mentioned in the schedule of the Act,
