DIRECTION NO. 223 OF 2017

OPERATION OF BEQUESTS, DONATIONS AND ENDOWMENTS FOR AWARDING MEDALS/PRIZES AND ANY OTHER DISTINCTIONS FOR ALL THE EXAMINATIONS(AMENDMENT) DIRECTION, 2017.

(Issued under Section 14(8) of the Maharashtra Universities Act, 1994.)

Whereas, the Maharashtra Universities Act 1994, has come into force w.e.f. 21st July 1994 i.e. Maharashtra Act No.xxxv of 1994, (hereinafter referred to as the Act)

AND

Whereas, the Act has been made applicable to the Gondwana University Gadchiroli from the date of establishment of the University;

AND

Whereas, the Management Council is empowered, under clause(n) of section 28 of the Act, to accept, on behalf of the university, the Trusts, Bequests and Donations to the University;

AND

Whereas, the Management council is empowered, Under provision of clause(0) of section 28 of the Act, to institute awards, medals & prizes and to prescribe rules therefor;

AND

Whereas, the matter is required to be regulated by an Ordinance;

AND

Whereas, No Ordinance was made for regulating the matter relating to medals, prizes & any other distinctions to the examinees in the Examinations;

AND

Whereas, to regulate the operation of Bequests, Donations and Endowments for awarding medals, Prizes & any other distinctions in the Examinations, the Vice-Chancellor has issued Direction No.168 of 2013 under provision of sub-section(8) of section 14 of the Act(Hereinafter referred to as the main Direction.)

AND

Whereas, Direction No. 3 of 2015 was issued by the Vice Chancellor for amending main Direction No. 168 of 2013;

AND

Whereas, 20 medals are regulated by Direction No. 168 of 2013 and 3 of 2015 issued by the Vice-Chancellor;

AND

Whereas, Direction No. 187 of 2016 was issued by the Vice-Chancellor, on 11/02/2016, for amending the main Direction No. 168 of 2013;

AND

Whereas, the numbers of medals increased to 26 from 20 from the date of issuance of Direction No. 187 of 2016;

AND

Whereas, the Management Council, in its meeting held on 7/10/2016, has accepted the donation received from shri. Devidas Sudam Ganvir, Bramhapuri of Rs. 1 Lakh for awarding the medal to an examinee who has secured highest number of marks in Bachelor of Arts Degree examinations in Ambedkar Thought taking into consideration all examinations of Bachelor of Arts in Ambedkar Thought together,

AND

Whereas, Direction No. 168 of 2013 including Direction No. 3 of 2015 & Direction No. 187 of 2016 were not converted into an Ordinance to be made in this behlf,

AND

Whereas, for institution of the Gold Medal namely 'Late smt.Bhumika Devidas Ganvir' the main Direction No. 168 of 2013 is required to be amended, Now, therefore, I, Dr. N.V.Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in exercise of the powers vested in me under provisions of sub-section(8) of section 14 of the Maharashtra Universities Act, 1994, do hereby issue following Directions to amend Direction No. 168 of 2013,:-

1. This Direction Shall be called "Operation of Bequests, Donations and Endowments for awarding medals/prizes and any other distinctions for all the examinations(Amendment), Direction, 2017."

- 2. This Direction shall come into force with effect from the date of its issuance.
- 3. In Direction, prescribing operation of Bequests, Donations & Endowments for awarding Medals/ prizes and any other Distinctions for all the examinations i.e. Direction No. 168 of 2013,
