**Direction prescribing incentive marks to the Participating collegiate students in the national service scheme (NSS), Adult and continuing education and extension services (ACEES), National cadet corps (NCC), Games & Sports and cultural Activities( Amendment) Direction,2015.**

Whereas, the Maharashtra universities Act no xxxv of 1994 has come in to force with effect from 22<sup>nd</sup> July 1994,

AND

Whereas, the above said Act has been made applicable to the Gondwana University, Gadchiroli from the date of its establishment.,

AND

Whereas, provision to provide incentive marks to the collegiate students of Gondwana University, Gadchiroli, for their participation in the N.S. S.,A.C.E.E.S, N.C.C ,Games & sports and cultural Activities conducted by the Gondwana University Gadchiroli has been made by issuing - Direction no 161 of 2013.,

AND

Whereas, the said Direction was required to be converted into an ordinance which could not be done.,

AND

Whereas, the matter is required to be regulated by an ordinance to be made in this behalf.

AND

Whereas, the provisions of Direction No 161 of 2013 are applicable to the collegiate students admitted to the undergraduate courses.,

AND

Whereas Department of Higher and Technical education in Maharashtra Government ,Mumbai has issued Government resolution bearing no. Raseyo-2014/ Pr.Kra. 42/14/sashi- 7 Dated 6/9/2014 stating in its para 5) as follows :-,

“ +2 स्तर, पदवी आणि पदव्युत्तर विभागातील विद्यार्थ्यांना रासेयोमध्ये प्रवेश देतांना या पूर्वी रासेयोतील सहभाग असणा-या विद्यार्थ्यांना प्राधान्य द्यावे ”,

Whereas, participation of students admitted to Post Graduate courses is allowed in N.S.S. Programme by the State Government,

AND

Whereas ,provision for granting incentive marks to the Post Graduate students admitted in N.S.S. Programme is to be made in the existing Direction No. 161 of 2013,

AND

Whereas, conversion of Direction No. 161of 2013 in to ordinance and amending the said ordinance for the above said purpose is time consuming process,

AND

Whereas, the Academic Session 2015-16 has already been started,

AND

Whereas, the benefit to participate in N.S.S. Programme is to be provided to the students admitted to the Post Graduate courses in the university in the academic session 2015-16 and onwards so that, they may take advantage of incentive markes for their participation N.S.S. Progrmme.,

Now, therefore, I **Dr.Murlidhar G.Chandekar**, Vice- Chancellor(Acting), Gondwana University Gadchiroli in exercise of the power conferred upon me under provision of sub-section (8) of section 14 of the Maharashtra Universities Act ,1994 do hereby issue the following Directions to amend Direction no . 161 of 2013:-

1. This Direction may be called **“Direction prescribing incentive marks to the Participating collegiate students in the national service scheme (NSS), Adult and continuing education and extension services (ACEES), National cadet corps (NCC), Games & Sports and cultural Activities( Amendment) Direction,2015.”**
2. This Direction shall come into force with effect from the date of its issuance.
3. In para 3 of Direction No. 161 of 2013 in respect of **““Direction prescribing incentive marks to the Participating collegiate students in the national service scheme (NSS), Adult and continuing education and extension services (ACEES), National cadet corps (NCC), Games & Sports and cultural Activities.”** (hereinafter referred to as the main direction) :-
  - (a) The letters appearing as “UG” be deleted.
  - (b) after the last word and sign “Gadchiroli”.the signs and words as “/University Post Graduate Departments” be added.
4. In para 4 of the main Direction:-
  - (a) after the last word and sign appearing as “Gadchiroli”. in clause ‘ii’ the words and signs as ‘conducting U.G./P.G. Degree Courses’. be added.
  - b) after clause ‘vi’ following clause ‘vii’ be added. ‘Vii “Departments” means the Departments of the Univetsity conducting Post Graduate Degree courses.
5. In para 5 of the main Direction ,after the word ‘college’ and before the word ‘


under', the sign and word as '/ Department ' be inserted.

6. In para 9 of the main Direction, after the words 'For degree' and before the word ' level', the sign and words as '/ Post Graduate degree' be inserted.

7. Para 12 of the main Direction be deleted.
