



# GONDWANA UNIVERSITY, GADCHIROLI

## Direction No. 19 of 2021

**“Operation of Bequests, Donation and Endowments for awarding Medal/Prizes and any other Distinctions in the Examinations, Direction, 2021.”**

**Whereas**, the Maharashtra Public Universities Act, 2016 has come into force with effect from 1<sup>st</sup> March 2017(i.e. Maharashtra Act No.VI of 2016);

**AND**

**Whereas**, the Act has been made applicable to the Gondwana University, Gadchiroli with effect from 1<sup>st</sup> March 2017;

**AND**

**Whereas**, Clause(k) of section 31 of the Act provides that the Management Council is empowered to accept, on behalf the university the transfer of any trusts, bequests, donation and transfer of any movable, immovable and intellectual property to the university;

**AND**

**Whereas**, sub-section(A) of section 71 of the Act provides that acceptance and management of trusts, bequests, donations, endowments and grants from individuals or organizations is a subject matter of the Statute;

**AND**

**Whereas**, in addition to the existing Gold Medals, two new Gold Medals are to be awarded in the ensuing 9<sup>th</sup> Convocation to an examinees which are not included in the existing Ordinance and Direction in-force;

**AND**

**Whereas**, making of Statute for regulating donations received to the university was time consuming process;

**AND**

**Whereas**, the matter is required to be executed with immediate effect;

Now, therefore, I, Prof. Shrinivasa Varakhedi, Vice-Chancellor, Gondwana University, Gadchiroli, in exercise of the powers vested in me under provision of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016, do hereby issue following Directions in respect of Operation of Bequest, Donations and Endowment funds for Awarding Medals/Prizes and any other Distinctions in the Examinations:-

1. This Direction shall be called "Operation of Bequests, Donations and Endowments for awarding Medals/Prizes and any other Distinctions for all the Examinations, Direction, 2021".
2. This Direction shall come into force with effect from the date of its issuance.
3. Below mentioned two new Gold Medals are to be awarded from the ensuing 9<sup>th</sup> Convocation to examinees which are not included in the existing Ordinance and Direction in-force.
