

 **GONDWANA UNIVERSITY, GADCHIROLI.**

Direction No. 38 of 2017

Additional Eligibility Conditions for Admission to Examination Leading to the First Semester of First year of the Degrees of B.A. B.Sc., B.C.A., B.C.C.A., B.Com, B.B.A., B.P.E and B.F.D. in Different Faculties in the university Direction,2017.

(Issued under section 12(8) of the Maharashtra Public Universities Act, 2016.)

Whereas, the Maharashtra Public Universities Act,2016 has been made applicable to Gondwana University Gadchiroli with effect from 1st March 2017

AND

Whereas, the Management Council has made Ordinances for the first Degree courses in the university to prescribe conditions under student shall be admitted to courses of studies for degree as provided under sub section (1) of section 73 of the above mentioned act;

AND

Whereas, Ordinance No.71 of 2017 is made for Bachelor of Physical Education Degree, Ordinance No. 109 of 2017 is made for Bachelor of Fashion Design Degree, Ordinance No. 111 of 2017 is made for Bachelor of Commerce Degree, Ordinance No. 114 of 2017 is made for Bachelor of Business Administration Degree, Ordinance No. 115 of 2017 is made for Bachelor of Computer Application Degree, Ordinance No. 117 of 2017 is made for Bachelor of Commerce and Computer Application Degree, Ordinance No. 119 of 2017 is made for Bachelor of Arts degree and Ordinance No. 121 of 2017 is made for Bachelor of Science Degree and Ordinance No.44 of 2017 is made for Certificate Course in Library and Information Science;

AND

Whereas, Higher and Technical Education Department in Government of Maharashtra vide Government Resolution No. VOC - 2012/591/C.N.245(A)/PE-4/dated.28 September, 2012 has granted equivalence to Two Years Diploma Courses conducted by the Maharashtra State Board of Vocational Education Examination with the 12th standard (All Faculties) examinations conducted by the Higher Secondary Education Board in the Maharashtra State;

AND

Whereas, the list of Vocational Courses under different course group is provided under ANNEXURE-A annexed with the Government Resolution mentioned in above para;

AND

Whereas, Considering the above mentioned Government Resolution, the Vice-Chancellor had appointed a committee for making recommendations of the courses included in the list annexed with Government Resolution vide ANNEXURE-A, for admission to the first semester of first year of the degree courses conducted in the university;

AND

Whereas, the committee appointed by the Vice-Chancellor has submitted its recommendation on 18/08/2017 stating that the Vocational diploma holders shall be eligible for admission to the first semester of first year of different degree courses in the university, on 18/08/2017;

AND

Whereas, the recommendations of the above mentioned committee were placed before the Academic Council meeting held on 23/08/2017 vide item No. 47 and the Academic Council has Resolved to approve the recommendations made by the Committee;

AND

Whereas, the recommendations approved by the Academic Council are required to be included in the existing Ordinances relating to the Degree/Certificate courses in the university;

AND

Whereas, the matter is required to be regulated by an Ordinance;

AND

Whereas, for including the recommendation of the Academic Council into the related ordinance, process of amending the existing related ordinance is to be completed;

AND

Whereas, Amending the existing Ordinance is a time consuming process;

AND

Whereas, provision for admission to Vocational diploma holders is to be made in the related Ordinance:-

Now, therefore, I, Dr. N.V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in exercise of the powers vested in me under provision of section 12(8) of the Maharashtra Public Universities Act, 2016, do hereby issue following directions to amend Ordinance Nos. 6 of 2017, 109 of 2017, 111 of 2017, 114 of 2017, 115 of 2017, 117 of 2017, 119 of 2017, 121 of 2017 and 44 of 2017 :-


1. This Direction shall be called "Additional Eligibility Conditions for Admission to Examination Leading to the First Semester of First year of the Degrees of B.A. B.Sc., B.C.A., B.C.C.A., B.Com. B.B.A., B.P.E. and B.F.D. and Certificate Course in Library and Information Science in Different Faculties in the university Direction, 2017."
2. This direction shall be applicable for the Academic year 2017-2018.

3. List of the courses conducted by the Maharashtra State Board of Vocational Education Examination having Standard 10th as entry qualification and of two years duration, Annexed with Government Resolution No. VOC-2012/591/C. N.245(A)/VE-4 dated 28th September, 2012 issued by the Higher & Technical Education Department, Government of Maharashtra is annexed with this direction as ANNEXURE-I.
4. The table under ANNEXURE-2 annexed with this Direction showing First Degree in the university as mentioned in Column No. 4 of the said table shall be the degree course for which the holders of the courses related to the code numbers mentioned in column No. 3 of the said table. (ANNEXURE-I), shall be eligible for admission to the first semester of the first year of the related degree course.
