

GONDWANA UNIVERSITY, GADCHIROLI DIRECTION NO 11 of 2023

Admission of Students and Conduct of Examinations Leading to the Award of One Year Post Graduate Diploma In Social Work Entitled "Social Program On Addiction in Rural Community (SPARC)" under Credit System in the Faculty of Inter-Disciplinary Studies, Direction 2023".

Whereas, The Maharashtra Public Universities Act, 2016 (Maharashtra Act No. VI of 2017) (hereinafter "the Act") governs the Gondwana University, Gadchiroli (hereinafter "the University");

AND

Whereas, the National Education Policy (NEP) 2020 focuses on education and skill development as per the needs of the community. There is need to create specialized manpower with capabilities, skills and experience in order to work on addiction control in the society. Therefore, the University is introducing one year post-graduate diploma in Social Work entitled, "Social Program On Addiction in Rural Community (SPARC)", under credit system in the Faculty of Inter-Disciplinary Studies based on the local needs of addiction control in rural and tribal communities and it will be offered by the Model Degree College, a constituent college of the University;

AND

Whereas, as per provisions of section 73(1) of the Act, an ordinance is required to frame to lay down the conditions under which students can be admitted to courses of study for award of a diploma but since, making of an ordinance is a time consuming process and there is an urgency for introduction of the new one year post graduate diploma in social work entitled, "Social Program On Addiction in Rural Community (SPARC)", under credit system in the Faculty of Inter-Disciplinary Studies;

Now, therefore, I, Dr. Prashant Shridhar Bokare, Vice-Chancellor of the University, in exercise of my powers under section 12(8) of the Act, do hereby issue the following Directions.

1. This Direction shall be called" Admission of Students and Conduct of Examinations Leading to the Award of One Year Post Graduate Diploma In Social Work Entitled "Social Program On Addiction in Rural Community (SPARC)" under Credit System in the Faculty of Inter-Disciplinary Studies, Direction 2023".

- 2. This direction shall come into force from the date of its issuance.
- 3. Definitions:-In this Direction, unless the context requires otherwise, the words and phrases shall have the meaning given hereunder.
 - a) "Application Form" means a form prescribed by the University for seeking admission to the diploma under this direction.
 - b) "Competent Authority" means the Authority appointed by the Vice-Chancellor, for any specific purpose of the diploma programme under this Direction.
 - c) "Program" means the full time one-year Post-graduate diploma in the social work entitled, "Social Program On Addiction in Rural Community (SPARC)".
 - d) "Course" means a subject or a paper offered in any semester under the programme.
 - e) "Credit" refers to the weightage given to a course, in terms of the number of instructional hours per week assigned to it. In this direction one credit means one hour of teaching work or two hours of practical work.
 - f) "Credit System" means, the system in which weightage of credits is spread over to different semesters during the period of study.
 - g) 'Grade letter' is an index to indicate the performance of a student in particular course. It is the depiction of actual marks secured by a student by a letter, the Grade letters are as given in Table 3.
 - h) 'Grade point' is the weightage allotted to each grade letter depending on the range of marks awarded in a course.
 - i) "HSSC" means the Higher Secondary School Certificate (Standard XII) examination conducted by Maharashtra State Board of Secondary and Higher Secondary Education or itsequivalent certificate awarded by any other recognized Board.
 - j) "Qualifying Examination" means an examination on the basis of which a candidate becomes eligible for admission to the Post-graduate diploma course in the social work entitled, "Social Program On Addiction in Rural Community (SPARC)" or its equivalent examination.
- 4. In order to conduct the admission process for admitting students to one year post-graduate diploma programin the social work entitled, "Social Program On Addiction in Rural Community (SPARC)" of the University, the Vice Chancellor shall appoint the "Competent Authority".
- 5. Intake capacity, Eligibility for application, Selection procedure for admission, Course fee, Pre-Course, Stipend and Curriculum for this Program an Examination fees will be as shown in Table 1 below:

6. PROGRAM LEARNING OUTCOMES

The SPARC diploma program is exclusively based on the principle of *Nai talim*by Vinobaji Bhave and Mahatma Gandhi. The focal emphasis of this program is education based on actual work experience. This kind of innovative education culture is expected to develop following skill-sets amongst the students;

- 1. What is addiction and how to identify it?
- 2. How to measure the scale/level of addiction in the community?
- 3. What and How to provide health-education to various stakeholders? (school/colleges, villages and Individuals)
- 4. How to organize rural/tribal people for addiction prevention? (Gram Sabha, Women and Tribal Organizations).
- 5. How to mobilize social action against liquor and tobacco consumption?
- 6. How to get cooperation of administration? (law, police, tahasildar, education and tribal department)
- 7. How to create effective awareness through social media and conventional media?
- 8. How to create effective addiction-remedy? At village and taluka level clinics and counseling and follow up with patient.
- 9. How to effectively manage, plan and coordinate our work?
- 10. How to effectively evaluate and impact assessment of any social program?

7. EVALUATION OF THE PROGRAM

NEP 2020 provides for innovative and interchangeable curricular structures to enable design of creative Courses/Programs in various disciplines of study leading to Degree/Diploma/PG Diploma/Certificate of Study offering multiple entry and multiple exit facilities, while removing the rigid curricular boundaries and creating new possibilities of life-long learning.

Accordingly, the internal and university assessment of student performance shall be carrying the weightage as mentioned in the Teaching and Examination Scheme given below.

Note:

1. Credit Calculations:

- One credit would mean equivalent of 40academicteaching periods of 60 minutes for Theory. For field work, the Credit Weightage for equivalent hours shall be 50% that of for theory periods.
- 40 contact hours equals to 12 credits per semester and 24 credits for two semesters viz one year duration 20 contact hours equals to 6 credits per semester and 12 credits for two semesters viz one year duration

The assessment of student's performance incorporates a suitable evaluation scheme based on their performance in different methodological tests/evaluations as mentioned below:

- a) Experiential Learning (Monthly Evaluations) This is in the form of continuous assessment done every month and shall have various components of evaluation as given below:
- Monthly feedback taken and submitted by Taluka Organizer/s
- Zonal training featuring Action Reflection Workshop of 36 hour duration at south, north and mid-zone of Gadchiroli district respectively
- Capacity building training at SEARCH of 3 days per month duration
- Maintenance of Daily Diary in the given proforma
- Reading material, to be referred weekly and feedback to be reflected in zonal trainings
- Monthly Information Sheet (MIS) featuring details as to work done as individual and as team, field visits, organizational meetings, camps, counseling sessions, group therapy, data identification and usage, surveys, interpretations and analysis etc.
- b) Study Essay Every student shall be required to submit a Study Essay highlighting the work done with specific details as part of curricular requirement of the given program. This will be evaluated by the SEARCH/Muktipath.

- c) Oral evaluation Oral evaluation shall be conducted by the university and that the university appointed examiners shall assess against marks allotted to this parameter.
- d) Marks to Letter Grade & Grade Point Conversion

The marks scored by the examinees in their courses/heads of passing of the program shall be converted into Letter Grade and Grade Point as per Table given below:

*Note: As such, the lowest passing Grade in any passing head shall be 'D'.

e. Calculation of Grade Point Average (GPA)

The Grade Point Average (GPA) shall be calculated for the program and shall be evaluated as mentioned below:

GPA =
$$\frac{\sum_{i=1}^{3} (C_i \times G_i)}{\sum_{i=1}^{3} C_i}$$

Where C_i is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.

The percentage of marks scored based on obtained GPA can be evaluated using below given formula.

$$Percentage = (GPA - 0.75) * 10$$

8. Division of Passing

The Division of Passing shall be based on GPA secured by an Examinee as shown in the Table 3 below:

- 9. Declaration of result is based on the Grade Point Average (GPA) earned towards the end of the program as given in Table 3. The names of the successful examinees passing the examination as a whole in the minimum prescribed period and obtaining prescribed number of places securing the grades as per adopted credit-grade system shall be arranged in order of merit as provided in ordinance relating to examinations in General.
- 10. Provisions with respect to grace marks for passing in a particular course/ head of passing and improvement of Division (Higher Class) and getting Distinction in any course shall be as per relevant Direction/Ordinance of the University.
- 11. An examinee who does not qualify in examination or remain absent for the examination, shall be eligible to appear in the same re-examination, on payment of re-examination fee and such other fees as may be prescribed from time to time, within 30 days from the date of result.
- 12. Successful examinees who secure minimum prescribed registered credits (40) for the program duration shall be entitled to receive a Certificate ofone year post graduate Diploma in Social Work entitled "Social Program On Addiction in Rural Community (SPARC)" in the Faculty of Inter-Disciplinary Studies signed by the Vice Chancellor of the University on payment of prescribed fees.
- 13. In the event of any query regarding interpretation/application of any provision of this direction, the Director Board of Examination and Evaluation shall refer the matter for the decision of the Dean of the Faculty of Inter-Disciplinary Studies or alternatively to the Board of Deans if found necessary.

14. MANAGEMENT OF THE COURSE

The execution and administration system of the SPARC course will be as follows.

- a) The given course shall be designed and delivered as per various clause and provisions made under MoU between SEARCH Foundation, Chatgaon and Gondwana University, Gadchiroli.
- b) A Program Advisory & Monitoring Committee shall oversee smooth functioning of the course.
- c) The entire responsibility of the management of SPARC program and providing education to the admitted candidates will be on SEARCH and Gondwana University Gadchiroli. The required highly qualified skilled manpower and program for the SPARC will be provided jointly by the Gondwana University and SEARCH.
- d) For the effective management of SPARC program, there will be a three member committee of senior representatives of SEARCH, Muktipath and Gondwana University. The convener for the said committee will be appointed by SEARCH.
- 15. For any other matter pertaining to SPARC program and its final award which is beyond the purview of this Direction, it shall be referred to the Vice-Chancellor and that the decision of the Vice-Chancellor shall be final and binding on all the concerned.
