



## **GONDWANA UNIVERSITY, GADCHIROLI.**

### **Direction No. 17 of 2022**

(Issued u/s 12 (8) of the Maharashtra Public Universities Act, 2016)

### **“Direction prescribing Boards of Studies Direction, 2022”**

(Under section 40 (1) of the Maharashtra Public Universities Act, 2016)

**Whereas**, the Maharashtra Public Universities Act, 2016 has been made applicable to the Gondwana University, Gadchiroli with effect from 1<sup>st</sup> March 2017 (Hereinafter referred to as the Act.);

**AND**

Whereas, Sub-section (2) of section 34 of the Act provides faculties in the university namely, Faculty of Science and Technology, Faculty of Commerce and Management, Faculty of Humanities, and Faculty of Inter-Disciplinary Studies;

**AND**

**Whereas**, Faculties in the university are prescribed by issuing Direction No. 9 U of 2017 by the Vice-Chancellor under provision of section 12 (8) of the Act;

**AND**

**Whereas**, sub-section (3) of section 34 of the Act provides that each faculty shall comprise such subjects as prescribed by the Statutes;

**AND**

**Whereas**, Direction No. 10 of 2017 in respect of the List of subjects comprised in each faculty in the University is issued by the Vice-Chancellor under provision of section 12(8) of the Act;

**AND**

**Whereas**, original Statute - 23 in respect of 'Boards of studies' is in existence in the university which was passed by the R.T.M. University Nagpur and was made applicable to the Gondwana University, Gadchiroli;

**AND**

**Whereas**, provisions made under original statute 23 in respect of 'Boards of studies' are now inconsistent with the provisions made under the Act because of the original Statute – 23 was prepared taking into consideration of the then ten faculties in the University;

**AND**

**Whereas**, the Act has provided only Four Faculties in the university, because of which it was necessary to merge the then ten faculties in the four faculties provided under the Act;

**AND**

**Whereas**, the Academic Council in its meeting held on 30/05/2017 Vide item No. 33 on the Agenda has resolved to merge the existing faculties in the University into the newly provided four faculties by the Act;

**AND**

**Whereas**, while resolving the merger of the existing ten faculties in the University into the newly provided four faculties by the Act, the Academic Council has authorized the Vice-Chancellor to make suitable changes in resolved merger of the faculties on the basis of the instructions/ guidelines to be issued from the State Government;

**AND**

**Whereas**, the Joint Secretary, Higher and Technical Education Department, Government of Maharashtra vide Letter No. Sankirn-2017/P.K. 279/UE-3 dated 22<sup>nd</sup> June 2017 has issued guidelines for merging of the old faculties into the faculties provided under the Act;

**AND**

**Whereas**, considering the guidelines received from the State Government, the merging of the then ten existing faculties into the newly provided four faculties was to be made;

**AND**

**Whereas**, in the light of guidelines received from the State Government, each faculty provided under the Act was to be allotted the subjects which were previously allotted to the then ten existing faculties in the University;

**AND**

**Whereas**, the matter relating to the Board of studies for every subject or group of subjects comprised in each faculty is required to be regulated by the Statute;

**AND**

**Whereas**, Board of studies for every subject or group of subjects comprised in each faculty is required to be prescribed in the university;

**AND**

**Whereas**, providing Board of Studies for every subject or group of subjects comprised in each faculty in the university is required to be regulated by the Statute as provided under section 40 (1) of the Act;

**AND**

**Whereas**, preparing and passing of the Statute by the Senate is time consuming process;

**AND**

**Whereas**, elections of the Boards of studies which are applicable to the Gondwana University, Gadchiroli are required to be conducted by the University.

**AND**

**Whereas**, Direction No. 11 of 2017 in respect of "Boards of Studies Direction, 2022" was issued by the Vice-Chancellor on 7/07/2017 under the provision of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016;

**AND**

**Whereas**, the above stated Direction No. 11 of 2017 is automatically lapsed on dated 6/01/2018;

**AND**

**Whereas**, it is expedient to revise and re-issue the Direction No 11 of 2017 considering the exigency of the situation;

**AND**

**Whereas**, the matter is required to be regulated by the statute;

**AND**

**Whereas**, preparing statute, passing it by the senate and assent to it by the Chancellor is a time consuming process;



**AND**

**Whereas**, the matter is required to be executed with immediate effect.

**Now**, therefore, I, Dr. Prashant S. Bokare, Vice-Chancellor, Gondwana University, Gadchiroli, in exercise of the powers conferred upon me under provision of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016, do hereby issue following Direction:-

1. This Direction may be called "Direction Prescribing Board of Studies Direction, 2022."
2. This Direction shall come into force from the date of its issuance.
3. Each faculty namely, 1) Science and Technology, 2) Commerce and Management, 3) Humanities, and 4) Inter-disciplinary studies, in the University shall comprise such Boards of studies for the subject or group of subjects as mentioned under the number and the name of the faculty under the **Schedule** annexed with this Direction.
4. original Statute - 23 in respect of 'Boards of Studies' of R.T.M. Nagpur University, Nagpur which was made applicable to the Gondwana University, Gadchiroli, in its application to this university shall stand repealed.
