### Direction No.20 of 2023

## Conditional Admissions to the Failed Students in all Under Graduate Programs of the University, Direction, 2023

Whereas, the Maharashtra Public Universities Act, 2016, has come into force with effect from 1<sup>st</sup> March, 2017 (Maharashtra Act No.VI of 2017)(hereinafter the "Act") and the same has been made applicable to the Gondwana University, Gadchiroli (hereinafter the "University");

#### AND

Whereas, Academic Council of the University has unanimously taken a resolution in it's meeting dated on 21<sup>st</sup> September 2023 to promote the failed students in Summer-2023 examinations of the University to the next year of the same Under Graduate Degree with some conditions as a special case for the academic year 2023-2024;

### AND

Whereas, as per section 73(1) of the Act, an Ordinance needs to be framed for laying down conditions under which students shall be admitted to courses of study for degrees; but since making Ordinance is a time consuming process and there is an exigency to carry forward the failed students in Summer-2023 examinations;

Now, therefore, I, Dr. Prashant S. Bokare, Vice-chancellor of the University, in exercise of the powers vested upon me under provision of section 12(8) of the Act, do hereby issue following Directions:-

- 1. This Direction shall be called "Conditional Admissions to the Failed Students in all Under Graduate Programs of the University, Direction, 2023".
- 2. This Direction shall come into force with effect from the date of its issuance.
- 3. The Under Graduate students failed in Summer-2023 Examinations shall be eligible to get admissions to the next year/odd semesters of the same Under Graduate Program in academic year 2023-2024 as a special case, provided that:
  - a. Such students shall pay non-refundable full admission fees and examinations fees of one year/ two Semesters before Winter-2023 Examinations. However, such student will be allowed only to appear at Winter 2023 examination in which he/she has backlog in Summer 2023 examination, but they will not be allowed to appear for the regular Winter-2023 examinations of the current semester.

- b. After Winter-2023 examinations, if student fails to qualify the eligibility conditions as per existing ATKT rules for the admissions to the next semester where the student is actually admitted, his/her admission shall be treated as cancelled automatically.
- c. After Winter-2023 examinations, if a student qualifies the eligibility conditions as per existing ATKT rules for the admissions to the next semester where the student is actually admitted, he/she will be considered as eligible for the admission to the year/semester in which the student is actually admitted. Such students shall be eligible for all the examinations of that year/two semesters together in Summer-2024 Examinations.
- 4. In the event of any difficulty arising out of interpretation /implementation of provisions of this Direction the matter shall be referred to the Vice Chancellor, whose decision shall be final and binding on all the concerned parties.
